On 3 August 1984 the Directorate of Publications appealed under section 14 of the Publications Act, 1974, against the decision on 2 August 1984 of a committee referred to in section 4 of the said Act, that the undermentioned publication is not undesirable within the meaning of section 47 (2) of the said Act. The period within which persons referred to in section 14 (3) (b) of the said Act may make representations to the Publications Appeal Board, Private Bag X114, Pretoria, in respect of the said appeal is hereby determined as 10 days from the date of this notice.
