ACT

To amend the Justices of the Peace and Commissioners of Oaths Act, 1963, so as to alter the references to the heads of the respective sections of the staff of Parliament in accordance with the new designations of those sections.

(Assented to 12 July 1984.)*

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. The First Schedule to the Justices of the Peace and Commissioners of Oaths Act, 1963, is hereby amended by the substitution for the third item of the following item:
“Secretary, Deputy Secretary, Under Secretary or Assistant Secretary to Parliament and the heads of the following sections, namely—
[Public Bill Section;
Hansard Section (House of Assembly);
Hansard Section (Senate);
Translating Section;
Serjeant-at-Arms Section;
Accounts Section;
10 Library to Parliament]
Legislation and Proceedings;
Committees;
Hansard;
Administration;
20 Library.”.

2. This Act shall be called the Justices of the Peace and Commissioners of Oaths Amendment Act, 1984. Short title.
