FINANCIAL RELATIONS AMENDMENT ACT, 1984

Act No. 114, 1984

GENERAL EXPLANATORY NOTE:

ACT

To amend the Financial Relations Act, 1976, so as to make provision for the imposition, by provincial councils, of levies on certain motor vehicles.

*(English text signed by the State President.)
(Assented to 12 July 1984.)*

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Schedule 1 to the Financial Relations Act, 1976, is hereby amended by the insertion after item 4 of the following item:
5 “4A. A levy, over and above payments in respect of licences or tax contemplated in items 3 and 4, on any motor vehicle with a gross vehicle mass of 5 000 kg or more registered in a province in terms of any law relating to the licensing and registration of motor vehicles.”.Amendment of Schedule 1 to Act 65 of 1976.
- 10 2. This Act shall be called the Financial Relations Amendment Act, 1984.Short title.
