

ISSUE OF INTERNAL REGISTERED STOCK, 14,50 PER CENT, 2006, AND INTERNAL REGISTERED STOCK, 15,0 PER CENT, 1988, OF THE REPUBLIC OF SOUTH AFRICA

The undermentioned Republic of South Africa Internal Registered Stock will be issued on a tender basis on 15 October 1984:

A. An issue of Internal Registered Stock, 14,50 Per Cent, 2006, to a nominal value of R200 000 000 with—

- (i) interest payments on 15 April and 15 October on a half-yearly basis; and
- (ii) redemption on 15 October 2006, at par.

B. A re-issue of Internal Registered Stock, 15,0 Per Cent, 1988, to a nominal value of R100 000 000 with—

- (i) interest payments on 15 April and 15 October, on a half-yearly basis; and
- (ii) redemption on 15 October 1988, at par.

Tenders on official tender documents, must be in multiples of R10 000 with a minimum of R50 000 at a Rand price per centum calculated and rounded off to five (5) decimal places and must be accompanied by a first payment of at least 25 per cent of the nett amount of the stock tendered for.

The balance, or portions thereof, of the amounts payable by successful tenderers must be paid not later than 12h00 on 1 November 1984.

Tenders must be handed in at the Treasury, Room 301, Abattoir House, 50 Hamilton Street, Pretoria, not later than 11h00 on Friday, 12 October 1984.
