PROCLAMATION

PROVINCIAL COUNCIL BY-ELECTION.—ELECTORAL DIVISION OF NEWTON PARK

1. Under the powers vested in me by section 110 of the Electoral Act, 1979 (Act 45 of 1979), I hereby declare that a vacancy has occurred in the representation of the Electoral Division of Newton Park in the Provincial Council of the Province of the Cape of Good Hope on account of the resignation of Mr Jakobus Johannes Crouse with effect from 22 February 1985.

2. Under the powers vested in me by section 33 of the Electoral Act, 1979 (Act 45 of 1979)—

(a) I hereby determine, in terms of the provisions of sections 34 and 110 of the said Act—

(i) that Monday, 25 March 1985 shall be the day on which a nomination court will sit to receive nominations of candidates for election as a member of the Provincial Council of the Province of the Cape of Good Hope for the Electoral Division of Newton Park;

(ii) that the said nomination court shall sit in the Conference Room, Department of Home Affairs, First Floor, Golden Mile Centre, Main Street, Port Elizabeth;

(iii) that if a poll becomes necessary in the said electoral division for the reason that more than one person shall have been duly nominated at the close of the sitting of the nomination court in question, the poll shall be taken on Wednesday, 1 May 1985 and shall commence at 07h00 and shall close at 21h00 on that day; and

(b) I hereby appoint, in terms of the said provisions, the Regional Representative, Department of Home Affairs, Port Elizabeth, as the returning officer at the election in the Electoral Division of Newton Park.

(ii) dat bedoelde nominasiehof sitting sal hou in die Konferensiekamer, Departement van Binnelandse Sake, Eerste Verdieping, Golden Mile-sentrum, Hoofstad Port Elizabeth;

(iii) dat ingeval 'n stemming nodig word in die kiesafdeling omdat meer as een persoon behoorlik gekies is, die stemming sal plaasvind op Woensdag, 1 Mei 1985 sal plaasvind op 07h00 op bedoelde dag sal begin en om 21h00 daardie dag sal eindig; en

(b) stel ek hierby ingevolge bedoelde bepalings die Streekverteenwoordiger, Departement van Binnelandse Sake, Port Elizabeth, as kiesbeampte aan by die verkiesing in die kiesafdeling Newton Park.
