ADDITIONAL APPROPRIATION ACT, 1985

ACT

To appropriate an additional amount of money for the requirements of the State during the financial year ending 31 March 1985.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Appropriation

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the State during the financial year ending 31 March 1985, as a charge to the State Revenue Account, the additional amounts of money shown in column 1 of the Schedule. 5

Short title.

2. This Act shall be called the Additional Appropriation Act, 1985.
