MINISTRY OF LAW AND ORDER**No. 776****29 March 1985****GATHERINGS PROHIBITED UNDER SECTION 46 (3) OF THE INTERNAL SECURITY ACT, 1982**

Whereas I, Louis le Grange, Minister of Law and Order, deem it expedient for the maintenance of the public peace, I hereby prohibit, under section 46 (3) of the Internal Security Act, 1982 (Act 74 of 1982), any gathering during the period 29 March 1985 up to and including 30 June 1985 in any building situated within any magisterial district specified in Schedule 1, if such gathering is a gathering organised, convened or held or otherwise brought about—

- (a) by or under the auspices or with the assistance of any organisation specified in Schedule 2; or
- (b) to advise, encourage, instigate or incite, except in so far as it is not prohibited in accordance with the provisions of section 65 of the Labour Relations Act, 1956 (Act 28 of 1956), any person to leave his work or service or not to return thereto or to delay or impede it,

unless any such gathering is authorised by me or, subject to the provisions of the said section 46 (3), by a magistrate of the district in which the gathering is contemplated.

- (a) deur of onder die beskerming of met die medewerking van 'n organisasie in Bylae 2 vermeld; of
- (b) om, behalwe vir sover dit nie ooreenkomsdig die bepalings van artikel 65 van die Wet op Arbeidsverhoudinge, 1956 (Wet 28 van 1956), verbied word nie, enige persoon aan te raai, aan te moedig, aan te stig of aan te hits om sy werk of diens te verlaat of nie daarheen terug te keer nie of om dit te vertraag of te belemmer,
