**ADDITIONAL APPROPRIATION ACT OF THE ADMINISTRATION:
HOUSE OF REPRESENTATIVES, 1985**

ACT

To appropriate an additional amount of money for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1985.

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1985, as a charge to the Revenue Account for Coloured Affairs, the additional amounts of money shown in column 1 of the Schedule. 5

Short title.

2. This Act shall be called the Additional Appropriation Act 10 of the Administration: House of Representatives, 1985.
