Act No. 40, 1985**POST OFFICE APPROPRIATION ACT, 1985****ACT**

To appropriate a sum of money for the requirements of the Department of Posts and Telecommunications in respect of the financial year ending 31 March 1986.

(Assented to 25 March 1985.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Appropriation of moneys for requirements of Department.

Purposes for which moneys may be spent.

Limitation on exceeding of certain appropriated amounts.

Short title.

1. Subject to the provisions of the Post Office Act, 1958 (Act No. 44 of 1958), there is hereby appropriated, as a charge to the Post Office Fund, for the requirements of the Department of Posts and Telecommunications in respect of the financial year ending 31 March 1986, the sums of money set forth in the Schedule. 5

2. The moneys appropriated by section 1 shall be applied to the purposes set forth in the Schedule and more particularly 10 specified in Part II of the Estimates of Revenue and Expenditure of the Department of Posts and Telecommunications [R.P. 15—1985], as submitted to and approved by Parliament.

3. Notwithstanding the provisions of section 12F (3) and (4) of the Post Office Act, 1958, an amount appropriated by this Act 15 for—

- (a) official entertainment;
- (b) the Post Office Sports Association;
- (c) grants-in-aid and contributions to—
 - (i) the S.A. Institute of Electrical Engineers; 20
 - (ii) the Philatelic Foundation of Southern Africa;
 - (iii) the University of Pretoria;
 - (iv) the University of Stellenbosch;
 - (v) the University of Natal;
 - (vi) the University of Cape Town; 25
 - (vii) the University of the Witwatersrand;
 - (viii) the Rand Afrikaans University;
 - (ix) die Potchefstroomse Universiteit vir C.H.O.;
 - (x) the Afrikaanse Taal- en Kultuurbond (Posts and Telecommunications); 30
 - (xi) the Services Golf Club, Pretoria;
 - (xii) the Post Office Christian Association;
 - (xiii) the South African Federation of University Engineering Students; and
 - (xiv) the Cape Provincial Administration for the development of the area in the vicinity of the historic Post Office tree at Mossel Bay, 35

may not be exceeded otherwise than in accordance with an authority granted under section 12F (5) (a) of the said Act.

4. This Act shall be called the Post Office Appropriation Act, 40 1985.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Behoudens die bepalings van die Poswet, 1958 (Wet No. 44 van 1958), word daar hierby bewillig, ten laste van die Poskantoorfonds, vir die behoeftes van die Departement van Pos- en Telekommunikasiewese ten opsigte van die boekjaar wat op 31 Maart 1986 eindig, die bedrae geld in die Bylae uiteengesit.
