AGRICULTURAL PESTS AMENDMENT ACT, 1985

ACT

To amend the Agricultural Pests Act, 1983, so as to emend the
text of section 13.

(Afrikaans text signed by the State President.)
(Assented to 12 March 1985.)

BE IT ENACTED by the State President and the Parliament
of the Republic of South Africa, as follows:—

Amendment of
section 13 of
Act 36 of 1983.

1. Section 13 of the Agricultural Pests Act, 1983, is hereby amended—
 - (a) by the substitution for subparagraph (i) of subsection 5 (1) of the following subparagraph:
“(i) on a first conviction of an offence in terms of paragraph (a), (b), (c), (d) or (e), to a fine not exceeding R5 000 or to imprisonment for a period not exceeding two years or to both such fine and such 10 imprisonment;”; and
 - (b) by the substitution, in the Afrikaans text, for subparagraph (iii) of subsection (1) of the following subparagraph:
“(iii) by skuldigbevinding weens ’n misdryf ingevalge 15 paragraaf (f), (g), (h), (i) of (j), strafbaar met ’n boete van hoogstens R600 of met gevangenisstraf vir ’n tydperk van hoogstens drie maande of met daardie boete sowel as daardie gevangenisstraf.”.

Short title.

2. This Act shall be called the Agricultural Pests Amendment Act, 1985.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 13 van die Wet op Landbouplae, 1983, word hierby gewysig—
- 5 (a) deur in die Engelse teks, subparagraph (i) van subartikel (1) deur die volgende subparagraph te vervang:
“(i) on a first conviction of an offence in terms of paragraph (a), (b), (c), (d) or (e), to a fine not exceeding R5 000 or to imprisonment for a period not exceeding two years or to both such fine and such imprisonment;”; en
- 10 (b) deur subparagraph (iii) van subartikel (1) deur die volgende subparagraph te vervang:
“(iii) by skuldigbevinding weens 'n misdryf ingevalle subparagraph (f), (g), (h), (i) or (j), strafbaar met 'n boete van hoogstens R600 of met gevangenisstraf vir 'n tydperk van hoogstens drie maande of met daardie boete sowel as daardie gevangenisstraf.”.

Wysiging van artikel 13 van Wet 36 van 1983.
