## ALTERATION OF PROVINCIAL BOUNDARIES ACT, 1985

**ACT**

**To provide that certain areas shall cease to form part of the Cape of Good Hope and shall be part of the Transvaal; and to provide for matters connected therewith.**

*(English text signed by the State President.)  
(Assented to 19 March 1985.)*

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Alteration of

and Transvaal.

Electoral matters.

**1.** (1) The areas described in the Schedule shall cease to form part of the province of the Cape of Good Hope and shall be part of the province of the Transvaal.

(2) As soon as may be practicable after the commencement of this Act, the Surveyors-General and Registrars of Deeds concerned shall give effect to the provisions of subsection (1) in such manner as may to them appear to be most practicable and convenient.

**2.** (1) For the purposes of—

(a) the election of members of the House of Assembly or a provincial council—

(i) the area described in Part 1 of the Schedule shall cease to be polling district No. 132 of the Electoral Division of Vryburg and shall be polling district No. 132 of the Electoral Division of Lichtenburg;

(ii) the area described in Part 2 of the Schedule shall cease to be polling district No. 52 of the Electoral Division of Vryburg and shall be polling district No. 52 of the Electoral Division of Lichtenburg;

(iii) the area described in Part 3 of the Schedule shall cease to be polling district No. 636 of the Electoral Division of Kimberley North and shall be polling district No. 636 of the Electoral Division of Schweizer Reneke;

(b) the election of members of the House of Representatives—

(i) the area described in Part 1 of the Schedule shall cease to form part of polling district No. 132 of the Electoral Division of Northern Cape and shall be part of polling district No. 314 of the Electoral Division of Rust Ter Vaal;

(ii) the area described in Part 2 of the Schedule shall cease to form part of polling district No. 132 of the Electoral Division of Northern Cape and shall be part of polling district No. 177 of the Electoral Division of Rust Ter Vaal;

(iii) the area described in Part 3 of the Schedule shall cease to be polling district No. 636 of the Electoral

**WET**

**Om te bepaal dat sekere gebiede ophou om deel van die Kaap die Goeie Hoop uit te maak en deel van Transvaal is; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.**

(Engelse teks deur die Staatspresident geteken.)  
(Goedgekeur op 19 Maart 1985.)

**DAAR WORD BEPAAL** deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:

1. (1) Die gebiede wat in die Bylae omskryf word, hou op om deel uit te maak van die provinsie die Kaap die Goeie Hoop en is deel van die provinsie Transvaal.  
 (2) So gou doenlik na die inwerkingtreding van hierdie Wet moet die betrokke Landmeters-generaal en Registrateurs van Aktes gevolg gee aan die bepalings van subartikel (1) op die wyse wat hulle die mees uitvoerbare en die gerieflikste beskou.

- 10 2. (1) Vir die doeleindeste van—  
 (a) die verkiesing van lede van die Volksraad of 'n provinsiale raad—  
     (i) hou die gebied wat in Deel 1 van die Bylae omskryf word, op om stemdistrik No. 132 van die kiesafdeling Vryburg te wees en is dit stemdistrik No. 132 van die kiesafdeling Lichtenburg;  
 15     (ii) hou die gebied wat in Deel 2 van die Bylae omskryf word, op om stemdistrik No. 52 van die kiesafdeling Vryburg te wees en is dit stemdistrik No. 52 van die kiesafdeling Lichtenburg;  
 20     (iii) hou die gebied wat in Deel 3 van die Bylae omskryf word, op om stemdistrik No. 636 van die kiesafdeling Kimberley-Noord te wees en is dit stemdistrik No. 636 van die kiesafdeling Schweizer-Reneke;  
 25     (b) die verkiesing van lede van die Raad van Verteenwoordigers—  
     (i) hou die gebied wat in Deel 1 van die Bylae omskryf word, op om deel uit te maak van stemdistrik No. 132 van die kiesafdeling Noord-Kaap en is dit deel van stemdistrik No. 314 van die kiesafdeling Rust Ter Vaal;  
 30     (ii) hou die gebied wat in Deel 2 van die Bylae omskryf word, op om deel uit te maak van stemdistrik No. 132 van die kiesafdeling Noord-Kaap en is dit deel van stemdistrik No. 177 van die kiesafdeling Rust Ter Vaal;  
 35     (iii) hou die gebied wat in Deel 3 van die Bylae omskryf word, op om stemdistrik No. 636 van die

- (c) the election of members of the House of Delegates—  
(i) the area described in Part 1 of the Schedule shall cease to form part of polling district No. 107 of the Electoral Division of North Western Cape and shall be part of polling district No. 127 of the Electoral Division of North Western Transvaal; 5  
(ii) the area described in Part 2 of the Schedule shall cease to form part of polling district No. 107 of the Electoral Division of North Western Cape and shall be part of polling district No. 137 of the Electoral Division of North Western Transvaal; 10  
(iii) the area described in Part 3 of the Schedule shall cease to form part of polling district No. 105 of the Electoral Division of North Western Cape and shall be part of polling district No. 136 of the Electoral Division of North Western Transvaal. 15

(2) As soon as may be practicable after the alteration of the boundaries of an electoral division by virtue of the provisions of subsection (1), the electoral officer for the area in which the electoral division is situated shall amend the voters' list in force in respect of the electoral division by removing the name and particulars of any person who, by reason of that alteration, has ceased to be entitled to registration as a voter in the electoral division or by adding the name and particulars of any person who, by reason of that alteration, became entitled to registration as a voter in the electoral division. 20

(3) For the purposes of the Electoral Act, 1979 (Act No. 45 of 1979), the amendment of a voters' list in terms of subsection (2) shall be deemed to be an amendment of the voters' list in terms of section 14 of that Act. 30

**Savings.**

3. Notwithstanding anything to the contrary contained in this Act or in any other law, the areas mentioned in section 1 shall, 35 for the purposes of sections 2, 3 and 10 of the Development Trust and Land Act, 1936 (Act No. 18 of 1936), be deemed to remain part of the province of the Cape of Good Hope.

**Short title and commencement.**

4. This Act shall be called the Alteration of Provincial Boundaries Act, 1985, and shall come into operation on a date determined by the State President by proclamation in the *Gazette*. 40

Begin by die noordelikste baken van die plaas Pendomer 844, administratiewe distrik Vryburg; daarvandaan klokgewys langs die grense van die volgende plase sodat hulle by hierdie gebied ingesluit word: genoemde plaas Pendomer 844, Killarney 845 en Home Rule 847 tot by die suidoostelike baken van laasgenoemde plaas; daarvandaan algemeen noordweswaarts langs die bestaande internasionale grens van Bophuthatswana en die Republiek van Suid-Afrika tot by die noordelikste baken van genoemde plaas Pendomer 844, die beginpunt.
