NOTICE OF APPLICATIONS FOR LIQUOR LICENCES AND SPECIAL AUTHORITIES, ETC., TO BE CONSIDERED AT AN ANNUAL MEETING OF THE LIQUOR BOARD

In terms of regulation 3 (1) and (4) of the regulations made under section 207 (1) of the Act, it is hereby notified that the applicants specified in the Schedule hereto have lodged applications for new liquor licences or special authorities in respect of premises situate in the districts (indicated in the Schedule) in the Province of

NATAL.

The applications will be considered at an annual meeting of the Liquor Board to be held during the period June and July 1985.

The applications concerned may, up to and including the last date on which an objection against or representations or a petition in support of such applications may be lodged in terms of the regulations, upon request and free of charge, be inspected by any person at the office of the magistrate of the district from which they emanate.

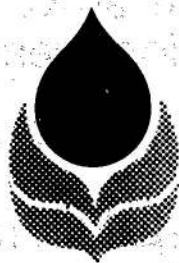
