APPROPRIATION ACT OF THE ADMINISTRATION: HOUSE OF DELEGATES, 1985

ACT

To appropriate an amount of money for the requirements of the Administration: House of Delegates during the financial year ending 31 March 1986.

BE IT ENACTED by the State President and the House of Delegates of the Republic of South Africa, as follows:—

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there is hereby appropriated for the requirements of the Administration: House of Delegates during the financial year ending 31 March 1986, the amounts of money shown in column 1 of the Schedule, with which the Revenue Account for Indian Affairs shall be charged. 5
