## HEALTH AMENDMENT ACT, 1985

## GENERAL EXPLANATORY NOTE:

## ACT

To amend the Health Act, 1977, so as to provide for the representation of the Administrations of the House of Delegates, House of Representatives and House of Assembly on the Health Matters Advisory Committee, and for the representation of the Ministers' Councils of the said Houses on the National Health Policy Council; and to provide for incidental matters.

(Assented to 12 June 1985.)

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 4 of Act 63 of 1977, as amended by section 2 of Act 33 of 1981 and section 2 of Act 2 of 1984.

1. Section 4 of the Health Act, 1977 is hereby amended—
- (a) by the deletion in subsection (1) of the word "and" at the end of paragraph (e);
  - (b) by the addition to subsection (1) of the following paragraph:
- “(g) an officer of each of the Administrations of the House of Delegates, the House of Representatives and the House of Assembly, who shall be designated by the Minister for Health Services and Welfare of the Ministers' Council concerned.”
- (c) by the substitution for subsections (2) and (3) of the following subsections, respectively:
- “(2) For every member of the committee appointed in terms of subsection (1) (d) or (e), there shall be an alternate member appointed in the same manner as such member of the committee, and a member of the committee referred to in subsection (1), (b), (c), [or] (f) or (g) may, with the consent of the Minister, designate a person in the service of the State in its Department of Health and Welfare, or of the South African Defence Force or of the relevant Administration referred to in subsection (1) (g), or in the service of the provincial administration concerned, as the case may be, to act in his stead as an alternate member of the committee, and any alternate member so appointed or designated may attend, and take part in the proceedings at, any meeting of the committee, whenever the member to whom he has been appointed or designated as alternate member is absent from such meeting.
- (3) The Secretary of the Public Service Commission for Administration or his nominee shall be entitled to attend meetings of the committee as an observer.”.

## WET

Tot wysiging van die Wet op Gesondheid, 1977, ten einde voorsiening te maak vir die verteenwoordiging van die Administrasies van die Raad van Afgevaardigdes, Raad van Verteenwoordigers en die Volksraad in die Adviserende Komitee vir Gesondheidsake, en vir die verteenwoordiging van die Ministersrade van genoemde Rade in die Nasionale Gesondheidsbeleidsraad; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 4 van die Wet op Gesondheid, 1977 word hierby gewysig—
- 5      (a) deur in subartikel (1) die woord "en" aan die einde van paragraaf (e) te skrap; en
- 10     (b) deur by subartikel (1) die volgende paragraaf te voeg:  
      "(g) 'n beampte van elk van die Administrasies van die Raad van Afgevaardigdes, die Raad van Verteenwoordigers en die Volksraad, wat deur die Minister van Gesondheidsdienste en Welsyn van die betrokke Ministersraad aangewys word.'"
- 15     (c) deur subartikels (2) en (3) deur onderskeidelik die volgende subartikels te vervang:  
      "(2) Vir elke lid van die komitee ingevolge subartikel (1) (d) of (e) aangestel, moet daar 'n plaasvervanginge lid op dieselfde wyse as bedoelde lid van die komitee aangestel word, en 'n in subartikel (1) (b), (c), **[of]** (f) of (g) bedoelde lid van die komitee, kan, met die toestemming van die Minister, 'n persoon in diens van die Staat in sy Departement van Gesondheid en Welsyn, of van die Suid-Afrikaanse Weermag of van die betrokke in subartikel (1) (g) bedoelde Administrasie, of in diens van die betrokke provinsiale administrasie, na gelang van die geval, aanwys om in sy plek as 'n plaasvervanginge lid van die komitee op te tree, en 'n plaasvervanginge lid aldus aangestel of aangewys, kan 'n vergadering van die komitee bywoon en aan die verrigtings aldaar deelneem wanneer die lid vir wie hy as plaasvervanginge lid aangestel of aangewys is, van bedoelde vergadering afwesig is.
- 20     (3) Die Sekretaris van die **[Staatsdienskommissie]** Kommissie vir Administrasie of sy benoemde is geregtig om vergaderings van die komitee as 'n waarnemer by te woon.".

**2.** Section 11 of the Health Act, 1977, is hereby amended by the addition to subsection (1) of the following paragraph:

**"(c) the Ministers of Health Services and Welfare of the  
Ministers' Councils of the House of Delegates, House  
of Representatives and the House of Assembly."**

**3.** This Act shall be called the Health Amendment Act, 1985, and shall be deemed to have come into operation on 3 September 1984.
