

REPUBLIC OF CISKEI CONSTITUTION AMENDMENT ACT, 1985
(ACT NO. 4 OF 1985)

REPUBLIC OF CISKEI CONSTITUTION ACT, 1985

ACT

To amend the Republic of Ciskei Constitution Act, 1981.

(English text signed by the President. Assented to on 20 June 1985).

BE IT ENACTED by the National Assembly of the Republic of Ciskei in terms of section 84(1) of the Republic of Ciskei Constitution Act, 1981, as follows: —

Substitution of section 27 of Act 20 of 1981, as substituted by section 2 of Act 10 of 1984.

1. The following section is hereby substituted for section 27 of the Republic of Ciskei Constitution Act, 1981 (hereinafter in this Act referred to as the principal Act):

"Acting President 27. (1) The President may at any time, whenever he is indisposed or otherwise temporarily unable to perform the duties of his office, by writing under his hand designate a member of the National Assembly to act as President during his pleasure.
(2) If the office of President becomes vacant or the President is for any reason (in circumstances other than those contemplated in subsection (1)) incapable of carrying out the duties of his office, a member of the National Assembly designated by the remaining members of the Executive Council shall act as President for the period for which the President is incapable of carrying out the duties of his office or, if the office of President is vacant, until a President is elected in terms of the provisions of sections 22 and 23."

Substitution of section 78 of Act 20 of 1981.

2. The following section is hereby substituted for section 78 of the principal Act:

"Affirmation 78. Except for the President and Ministers and Deputy Ministers of State, any person who is required by any provision of this constitution to make and subscribe an oath of office or any other oath may in lieu thereof make and subscribe a corresponding solemn affirmation."

Substitution of section 79 of Act 20 of 1981.

3. The following section is hereby substituted for section 79 of the principal Act:

"Protection 79. (1) Any person who, without authority in writing granted on behalf of the President, uses in connection with his business, trade, profession or occupation or in connection with any mark or description applied by him to or placed by him on goods made, produced or sold by him —
(a) the coat of arms of the Republic of Ciskei or anything so closely resembling such coat of arms as to be likely to deceive,
(b) the style, title, name, portrait or effigy of the President, a Minister or Deputy Minister of State or the Chief Justice, or
(c) a reproduction of the national flag of the Republic of Ciskei or of any official residence of the President, a Minister or Deputy Minister of State or the Chief Justice,
shall be guilty of an offence.
(2) Any person convicted of a contravention of any provision of subsection (1) shall be liable to a fine not exceeding five hundred rand or to imprisonment for a period not exceeding twelve months and the court which convicts such person may, in addition, order the confiscation to the State of all or any part of the goods in respect of which the offence was committed."

Amendment of Schedule 7 of Act 20 of 1981, as amended by section 6 of Act 7 of 1982.

4. Schedule 7 of the principal Act is hereby amended by the deletion of the particulars relating to the undermentioned Acts:

Act 58 of 1959 Inquests Act, 1959
Act 6 of 1973 Ciskeian Liquor Act, 1973
Act 3 of 1974 Ciskian Tribal Taxation Act, 1974
Act 53 of 1974 Pharmacy Act, 1974
Act 56 of 1974 Medical, Dental and Supplementary Health Service Professions Act, 1974
Act 7 of 1977 Ciskeian Police Act, 1977
Act 4 of 1978 Ciskeian Authorities, Chiefs and Headmen Act, 1978.

Short title.

5. This Act shall be called the Republic of Ciskei Constitution Amendment Act, 1985.
