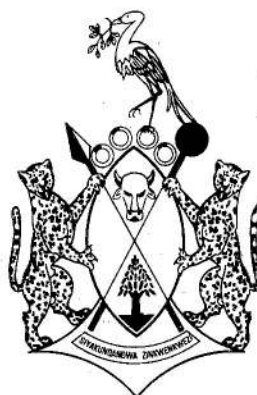

ADDITIONAL APPROPRIATION ACT, 1985

A C T

To appropriate an additional amount of money for the requirements of Republic of Ciskei during the financial year ending 31 March, 1985.

(English text signed by the President. Assented to on 21 June 1985.)

BE IT ENACTED by the National Assembly as follows:—

Appropriation of additional amount of money for requirements of Republic of Ciskei.

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975) there is hereby appropriated for the requirements of Republic of Ciskei during the financial year ending 31 March, 1985 the additional amount of money shown in Column 1 of the Schedule with which the Revenue Fund shall be charged.

Short title.

2. This Act shall be called the Additional Appropriation Act, 1985.
