Act No. 84, 1985

ANIMALS PROTECTION SECOND AMENDMENT ACT, 1985

GENERAL EXPLANATORY NOTE:

Words underlined with solid line indicate insertions in existing enactments.

ACT

To amend the Animals Protection Act, 1962, so as to empower the Minister of Justice to make regulations relating to the seizure and disposal or destruction of animals; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 10 of Act 71 of 1962, as amended by section 4 of Act 54 of 1983 and section 8 of Act 20 of 1985.

1. Section 10 of the Animals Protection Act, 1962, is hereby amended by the substitution for paragraph (c) of subsection (1) of the following paragraph:

“(c) the seizure, impounding, custody or confining of any animal due to any condition of such animal, the disposal or destruction of such animal and the recovery of any expenses incurred in connection therewith from the owner of such animal; and”.

Short title.

2. This Act shall be called the Animals Protection Second Amendment Act, 1985.

Tot wysiging van die Dierebeskermingswet, 1962, ten einde die Minister van Justisie te magtig om regulasies uit te vaardig met betrekking tot die inbeslagneming van en beskikking oor of afmaak van diere; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 10 van die Dierebeskermingswet, 1962, word hierby gewysig deur paragraaf (c) van subartikel (1) deur die volgende 5 paragraaf te vervang:

“(c) die inbeslagneming, skut, bewaring of inperking van 'n dier weens enige toestand waarin dié dier verkeer, die beskikking oor of afmaak van so 'n dier en die verhaal van onkoste in verband daarmee aangegaan van die eienaar van dié dier; en”.

Wysiging van artikel 10 van Wet 71 van 1962, soos gewysig deur artikel 4 van Wet 54 van 1983 en artikel 8 van Wet 20 van 1985.

2. Hierdie Wet heet die Tweede Dierebeskermingswysigingswet, 1985.
