### **POUNDS AMENDMENT ACT, 1985**

#### ACT

To amend the Pounds Act, 1984.

(English text signed by the President. Assented to on 08/08/1985.)

BE IT ENACTED by the National Assembly of the Republic of Ciskei, as follows:-

Amendment of section 1 of Act 43 of 1984. Section 1 of the Pounds Act, 1984 (hereinafter in this Act referred to as the principal Act) is hereby amended —
 (a) by the substitution for the definition of "Authorities Act" of the following definition:

"'Authorities Act' means the Administrative Authorities Act, 1984 (Act 37 of 1984);";

(b) by the substitution in the definition of "police official" for the words "Police Division of Ciskei" of the words "Ciskeian Police".

Amendment of section 3 of Act 43 of 1984.

2. Section 3 of the principal Act is hereby amended by the deletion in subsection (2) of the expression "mentioned in subsection (2)".

Amendment of section 4 of Act 43 of 1984.

3. Section 4 of the principal Act is hereby amended -

- (a) by the substitution in subsection (1) (I) for the expression "3(8)(a)(ii)" of the expression "3 (5) (a) (ii); and
- (b) by the substitution in subsection (4) (a) for the word "inspected" of the words "available for inspection".

Amendment of section 9 of Act 43 of 1984.

4. Section 9 of the principal Act is hereby amended -

- (a) by the substitution for paragraph (a) of subsection (1) of the following paragraph:
  - "(a) For the purposes of the determination of the special compensation contemplated in section 7 (1) (d) —

 the chairman of the tribal authority (assisted by not less than three other members of the trial authority) shall, within the area of the pound of that tribal authority, be the arbitrator;

(ii) the department shall, in respect of any area for which there is no tribal authority pound, appoint from amongst the officers of the Government in that area who are adequately qualified one or more persons to act as arbitrators."; and

(b) by the substitution for subparagraph (i) of subsection (4) (a) of the following subparagraph:

"(i) in the case of the arbitrator referred to in subsection (1) (a) (i), the amount of four rand which such arbitrator shall retain for his own use and that of his assistants; or".

Amendment of section 17 of Act 43 of 1984.

- Section 17 of the principal Act is hereby amended -
  - (a) by the insertion in subsection (2) (a) after the word "increase", in the English text, of the words "or decrease";

(b) by the substitution for subsectio (5) of the English text of the following subsection:

"(5) Where any animal which has trespassed on land outside a municipal area is impounded in the municipal pound, the fees and charges fixed for such pound shall be payable: Provided that if the municipal council suffers any loss as a result of such impoundment, it may recover such loss from the pound authority of the area in which the land trespassed upon is situated."

Short title.

6. This Act shall be called the Pounds Amendment Act, 1985.
