ORDERS BY THE COMMISSIONER OF THE SOUTH AFRICAN POLICE

Under regulation 6 of the Regulations in terms of the Public Safety Act, 1953, promulgated by Proclamation R. 121 of 21 July 1985, I, Petrus Johannes Coetzee, Commissioner of the South African Police, hereby issue with reference to the magisterial districts specified in the Schedule the following orders in respect of gatherings for the commemoration of the September 1984-riots in the Vaal Triangle:

PROHIBITION ON COMMEMORATIVE GATHERINGS

- (1) No person shall at any time and at any place attend, hold, organize or arrange any gathering commemorating, or relating to, the riots or other disturbances which took place in the Vaal Triangle during September 1984, or commemorating, or in connection with any event resulting from those riots or other disturbances, and no person shall propagate, encourage, promote such gathering or the attendance thereof or do so or attempt to do so by means of threats.
- (2) No person shall print, publish or disseminate a notice in which such a gathering has been arranged or advertised.
2. A Divisional Commissioner of the South African Police may, on written application, grant exemption from the above-mentioned orders.

BEVELE DEUR DIE KOMMISSARIS VAN DIE SUID-AFRIKAANSE POLISIE

Kragtens regulasie 6 van die Regulasies kragtens die Wet op Openbare Veiligheid, 1953, soos afgekondig by Proklamasie R. 121 van 21 Julie 1985, vaardig ek, Petrus Johannes Coetzee, Kommissaris van die Suid-Afrikaanse Polisie, met betrekking tot die landdrostdistrikte in die Bylae vermeld die volgende bevele uit ten opsigte van byeenkomste ter herdenking van die onluste in die Vaaldriehoek:

VERBOD OP HERDENKINGSBYEENKOMSTE

- (1) Geen persoon mag te eniger tyd en op enige plek enige byeenkoms ter herdenking van, of wat in verband staan met, die onluste of ander wanordelikhede wat gedurende September 1984 in die Vaaldriehoek plaasgevind het, of ter herdenking van, of wat in verband staan met enige gebeurtenis wat uit daardie onluste of ander wanordelikhede voortgespruit het, bywoon, hou, reël of belê nie en niemand mag sodanige byeenkoms of die bywoning daarvan propageer, aanmoedig, bevorder of deur middel van dreigemente teweegbring of poog om dit te doen nie.
- (2) Niemand mag 'n kennisgewing waardeur so 'n byeenkoms belê word of geadverteer word, druk, publiseer of versprei nie.
2. 'n Afdelingskommissaris van die Suid-Afrikaanse Polisie kan, op skriftelike aansoek, vrystelling van die bogenoemde bevele verleen.
