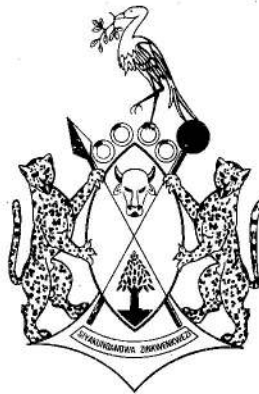

ACT

To repeal certain laws which are no longer required or which are in conflict with the laws of the Republic of Ciskei

English text signed by the President. Assented to on 14 August 1985.

BE IT ENACTED by the National Assembly of the Republic of Ciskei, as follows:-

- Repeal of laws.* 1. The laws mentioned in the Schedule are hereby repealed to the extent set out in the third column of the Schedule.
- Short title.* 2. This Act shall be called the Repeal of Laws Act, 1985.
