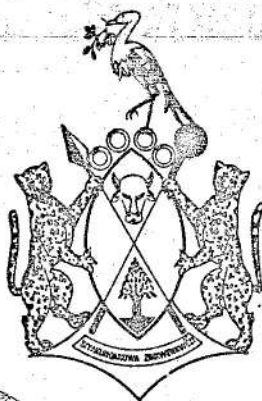


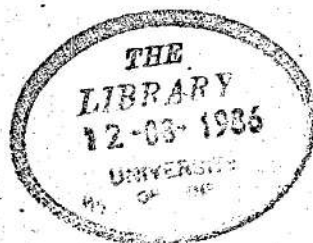

ADDITIONAL APPROPRIATION ACT, 1986

ACT

To appropriate an additional amount of money for the requirements of Republic of Ciskei during the financial year ending 31 March, 1986.

(English text signed by the President. Assented to on 20 June 1986.)

BE IT ENACTED by the National Assembly of the Republic of Ciskei as follows:—

1. **Appropriation of additional amount of money for requirements of Republic of Ciskei.** - Subject to the provisions of the Exchequer and Audit Act 1985 (Act No. 28 of 1985) there is hereby appropriated for the requirements of Republic of Ciskei during the financial year ending 31 March, 1986 the additional amount of money shown in Column 1 of the Schedule with which the Revenue Fund shall be charged.

2. **Short title.** - This Act shall be called the Additional Appropriation Act, 1986.
