**Tot wysiging van die Wet op Nasionale Parke, 1976, ten einde voorsiening te maak vir betaling van besoldiging aan die voorsitter van die Raad van Kuratore vir Nasionale Parke.**

**DAAR WORD BEPAAL** deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Vervanging van artikel 10 van Wet 57 van 1976.

**1.** Artikel 10 van die Wet op Nasionale Parke, 1976, word hierby deur die volgende artikel vervang:

"Toelaes van lede en besoldiging van voorsitter van raad.  
**10. (1)** 'n Lid van die raad ontvang geen besoldiging nie, maar sy redelike reis- en verblyfkoste ter wyl hy die sake van die raad verrig, kan teen 'n by regulasie voorgeskrewe tarief aan hom betaal word.

**(2)** Ondanks die bepaling van subartikel (1) kan die raad aan die voorsitter aangewys ingevolge artikel 5 (3) (c), met betrekking tot die werksaamhede wat hy in sy hoedanigheid van voorsitter verrig die besoldiging betaal wat die Minister, met die instemming van die Minister van Finansies, van tyd tot tyd goedkeur."

## NATIONAL PARKS SECOND AMENDMENT ACT, 1986

Act No. 111, 1986

## GENERAL EXPLANATORY NOTE:

## ACT

To amend the National Parks Act, 1976, so as to provide for the payment of remuneration to the chairman of the National Parks Board of Trustees.

(Afrikaans text signed by the State President.)  
(Assented to 10 September 1986.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. The following section is hereby substituted for section 10 of the National Parks Act, 1976:

5 "Allowances of members and remuneration of chairman of board.

10 10. (1) A member of the board shall not receive any remuneration but may be paid, at a tariff which may be prescribed by regulation, his reasonable expenses for travelling and subsistence while engaged on the business of the board.

15 (2) Notwithstanding the provisions of subsection (1), the board may pay to the chairman designated in terms of section 5(3)(c), with regard to the functions which he performs in his capacity as chairman such remuneration as the Minister may from time to time, with the concurrence of the Minister of Finance, approve."

2. This Act shall be called the National Parks Second Amendment Act, 1986. Short title.
