## PROCLAMATION

TRANSFER OF POWERS, DUTIES AND FUNCTIONS  
IN TERMS OF THE PREVENTION OF ILLEGAL  
SQUATTING ACT, 1951

By virtue of the powers vested in me by section 11 of the Prevention of Illegal Squatting Act, 1951 (Act 52 of 1951), I hereby provide that any power, duty or function which is permitted or required to be performed by the Dias, Cape, Paarl or Stellenbosch Divisions in the rural areas of their respective Divisional Areas in terms of the above-mentioned Act or any regulation issued thereunder, may, be or shall be, as the case may be, carried out or performed from 30 June 1987 by the Administrator of the Province of the Cape of Good Hope.

AFSKAFFING VAN SEKERE AFDELINGS EN SAKE

1. Kragtens die bevoegdheid aan my verleent by artikel 2 (2) van die Wet op die Afskaffing van Ontwikkelingsliggame, 1986 (Wet 75 van 1986), skaf ek hiermee die

bodies after consultation with the Administrator of the Cape of Good Hope and the Councils of the Divisions concerned, from 30 June 1987:

- 1.1 The Council and Division of the Cape.
- 1.2 The Council and Division of Paarl.
- 1.3 The Council and Division of Stellenbosch.
- 1.4 The Council and Division of Dias.
2. I furthermore declare, by virtue of the powers vested in me by section 2 (2) of the said Act, with the concurrence of the Minister of Finance, that—

- 2.1 all assets, liabilities, rights, duties and obligations in connection with the public resorts known as—

Antoniesvlei;  
Beachview;  
Gamtoos River Mouth;  
Imhoff Caravan Park;  
Macassar;  
Maitland River Mouth;  
Midfor;  
Miller's Point Recreation Area;  
Ou Skip Caravan Park;  
Peoples' Pleasure;  
Silverstroom Strand Resort;  
Soetwater Recreation Area;  
Van Staden's River Mouth;  
Fish River; and  
Willows,

situated in the Cape, Paarl, Stellenbosch and Dias Divisional Areas, shall pass to the Administrator of the Province of the Cape of Good Hope; and

- 2.2 all other assets, liabilities, rights, duties and obligations, which includes all rates and other monies validly levied by the development body concerned, of the development bodies mentioned in 1.1., 1.2 and 1.3 shall pass to the Regional Services Council for the Cape Metropole and Surrounding Areas established by Provincial Notice 4 of 1987 of 9 January 1987, and those of the development body mentioned in 1.4, shall pass to the Regional Services Council for the Port Elizabeth/Uitenhage Metropole and Surrounding Areas established by Provincial Notice 3 of 1987 of 9 January 1987:

Provided that the Administrator of the Province of the Cape of Good Hope may, after consultation with the above-mentioned public authority, Regional Services Council and the other public authority—

- (a) transfer such asset, liability, right, duty and obligation from the above-mentioned public authority to such other public authority from a date determined by him; and
- (b) in order to obtain a result which in his opinion is fair to all parties concerned, direct that compensation shall be payable when any asset or right is transferred.
