IMPOSITION OF CONTROL MEASURES ON THE ABSTRACTION OF PUBLIC WATER FOR AGRICULTURAL PURPOSES IN THE CROCODILE RIVER (WESTERN TRANSVAAL) GOVERNMENT WATER CONTROL AREA, WARDS 3, 4, 5 AND 6

I, Jacob Albertus van Wyk, Deputy Minister of Water Affairs, acting on behalf of the Minister of Water Affairs, by virtue of the powers vested in him by section 9A of the Water Act, 1956 (Act 54 of 1956), declare as follows:

1. That in my opinion there still exists a shortage of water in respect of the Crocodile River (Western Transvaal) Government Water Control Area;
2. that I have decided to release water for the area from the Klipvoor Dam from 14 August 1987;

Ek, Jacob Albertus van Wyk, Adjunk-minister van Waterwese, handelende namens die Minister van Waterwese kragtens die bevoegdheid hom verleen by artikel 9A van die Waterwet, 1956 (Wet 54 van 1956), verklaar soos volg:

1. Dat na my oordeel daar nog steeds 'n waternood in die Krokodilrivier(Wes-Transvaal)-staatswaterbeheergebied bestaan;
2. dat ek besluit het om vanaf 14 Augustus 1987 ook water uit Klipvoordam vir die gebied los te laat;

3. that in order to accomplish a proportionate distribution of available water in the area—

- (i) from and including the farm Buffelsdraai 151 JQ to and including the farm Rooisloot 142 JQ on the Pienaars River; and
- (ii) from and including the farms Boschkop 138 JQ on the left bank and Nooitgedacht 22 JQ on the right bank of the Crocodile River to and including the farms Buffelshoek 351 KQ on the left bank and Wachteenbietjiesdraai 350 KQ on the right bank of the Crocodile River;

the undermentioned measures will apply to all waterworks abstracting water for agricultural purposes in the area described above:

- (i) No water may be abstracted from the rivers concerned during the period between the moment that the released water has reached a water work and 07h00 on 21 August 1987;
- (ii) from 07h00 on 21 August 1987 until 07h00 on 1 September 1987 water may only be abstracted from the rivers concerned in order to irrigate standing crops and for domestic purposes;
- (iii) from 07h00 on 1 September 1987 water may be abstracted from the rivers concerned for all agricultural purposes;
- (iv) the volume of water to be abstracted from the rivers concerned between 07h00 on 21 August 1987 and 07h00 on 31 October 1987, may not exceed 2 400 m³ per scheduled hectare;
- (v) these measures do not apply to boreholes.

By virtue of the powers vested in me by section 165 of the said Act, I hereby authorise the Circle Engineer (Western Transvaal) to relax or extend or abrogate for an indefinite period at his discretion the measures set out in this notice considering a deterioration or improvement in the availability of water in the area, by means of a notice in the Gazette and in the case of abrogation, this notice shall be deemed to have been repealed by me.


