CREDIT AGREEMENTS AMENDMENT ACT, 1987

ACT

To amend the Credit Agreements Act, 1980, so as to further define certain expressions; and to provide for incidental matters.

*(English text signed by the State President.)
(Assented to 9 September 1987.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 75 of 1980, as amended by section 1 of Act 9 of 1985.

1. Section 1 of the Credit Agreements Act, 1980, is hereby amended—
 - (a) by the substitution for the definition of “initial payment” of the following definition:
“initial payment” means the amount to be paid by the credit receiver **[on the date]** in the case of a credit agreement which is a credit transaction;”; 5
 - (b) by the substitution for the definition of “initial rental” of the following definition:
“initial rental” means the amount to be paid by the credit receiver **[on the date]** in the case of a credit agreement which is a leasing transaction;”; and 10
 - (c) by the substitution for the definition of “Minister” of the following definition:
“Minister” means the Minister of **[Trade and Industry]** Economic Affairs and Technology;”. 15

Short title and commencement.

2. This Act shall be called the Credit Agreements Amendment Act, 1987, and shall be deemed to have come into operation on 2 March 1981. 20

Tot wysiging van die Wet op Kredietooreenkomste, 1980, ten einde sekere uitdrukkinge verder te omskryf; en om vir by-komstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 1 van die Wet op Kredietooreenkomste, 1980, word hierby gewysig—
- 5 (a) deur die omskrywing van "aanvanklike betaling" deur die volgende omskrywing te vervang:
 "aanvanklike betaling" die bedrag wat deur die krediet-opnemer betaal moet word **[op die datum] in die geval van** 'n kredietooreenkomste wat 'n krediet-transaksie is;"
- 10 (b) deur die omskrywing van "aanvanklike huurgeld" deur die volgende omskrywing te vervang:
 "aanvanklike huurgeld" die bedrag wat deur die kredietopnemer betaal moet word **[op die datum] in die geval van** 'n kredietooreenkomste wat 'n huur-transaksie is;" en
- 15 (c) deur die omskrywing van "Minister" deur die volgende omskrywing te vervang:
 "Minister" die Minister van **[Handel en Nywerheid] Ekonomiese Sake en Tegnologie".**
- 20 2. Hierdie Wet heet die Wysigingswet op Kredietooreenkomste, 1987, en word geag op 2 Maart 1981 in werking te tree het.
