ESTABLISHMENT OF A SMALL CLAIMS COURT

Under and by virtue of the powers vested in me by section 2 of the Small Claims Courts Act, 1984 (Act 61 of 1984), I, Hendrik Jacobus Coetsee hereby give notice that I—

- (a) establish for the area of Nelspruit consisting of the Districts of Nelspruit, White River, Barberton, Pilgrim's Rest and Lydenburg, a court for the adjudication of claims; and
- (b) determine Nelspruit, White River, Barberton, Sabie, Graskop and Lydenburg as places in the aforementioned area for the holding of sessions of such a court.
