## NATIONAL PARKS AMENDMENT ACT, 1987

## ACT

To amend the National Parks Act, 1976, so as to provide for remuneration of and payment of allowances to members of the National Parks Board of Trustees; and to rectify an incorrect reference; and to provide for matters incidental thereto.

(Assented to 9 September 1987.)*

**BE IT ENACTED** by the State President and the Parliament of the Republic of South Africa, as follows:—

Substitution of section 10 of Act 57 of 1976, as substituted by section 1 of Act 111 of 1986.

Amendment of section 12 of Act 57 of 1976, as amended by section 7 of Act 43 of 1986.

Amendment of section 29 of Act 57 of 1976.

Short title.

1. The following section is hereby substituted for section 10 of the National Parks Act, 1976 (hereinafter referred to as the principal Act):

“Remuneration and allowances of members of the board.

**10. A member of the board shall receive such remuneration and allowances as the Minister may with the concurrence of the Minister of Finance from time to time determine.”**

2. Section 12 of the principal Act is hereby amended by the substitution for subsection (5) of the following subsection:

“(5) The board may grant exemption or partial exemption from payment of any or all of the charges determined under subsection (2) **[(i)] (b) (ix)**, or the fees payable in terms of any regulation made under section 29 (1) (d), to 15 members of the board, to any officer and any employee, and to any particular other person.”

3. Section 29 of the principal Act is hereby amended by the deletion of paragraph (l) of subsection (1).

4. This Act shall be called the National Parks Amendment 20 Act, 1987.

**Tot wysiging van die Wet op Nasionale Parke, 1976, ten einde voorsiening te maak vir besoldiging van en betaling van toeplaes aan lede van die Raad van Kuratore vir Nasionale Parke; en 'n foutiewe verwysing reg te stel; en om voorsiening te maak vir aangeleenthede wat daar mee in verband staan.**

**DAAR WORD BEPAAL** deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 10 van die Wet op Nasionale Parke, 1976 (hieronder die Hoofwet genoem), word hierby deur die volgende artikel 5 vervang:

"Besoldiging en toeplaes van lede van die raad ontvang die besoldiging en toeplaes wat die Minister met die instemming van die Minister van Finansies van tyd tot tyd bepaal."

Vervanging van artikel 10 van Wet 57 van 1976, soos vervang deur artikel 1 van Wet 111 van 1986.

2. Artikel 12 van die Hoofwet word hierby gewysig deur subartikel (5) deur die volgende subartikel te vervang:

"(5) Die raad kan vrystelling of gedeeltelike vrystelling verleen van betaling van enige van of al die geldige kragtens subartikel (2) (i) (b) (ix) bepaal, of die geldige betaalbaar ingevolge enige regulasie kragtens artikel 29 (1) (d) uitgevaardig, aan lede van die raad, aan 'n beampete en 'n werknemer, en aan enige besondere ander persoon."

Wysiging van artikel 12 van Wet 57 van 1976, soos gewysig deur artikel 7 van Wet 43 van 1986.

3. Artikel 29 van die Hoofwet word hierby gewysig deur paraaf (l) van subartikel (1) te skrap.
