Act No. 102, 1987 UNEMPLOYMENT INSURANCE SECOND AMENDMENT ACT, 1987

GENERAL EXPLANATORY NOTE:

ACT

To amend the Unemployment Insurance Act, 1966, so as to make further provision, with retrospective effect, in relation to the benefits to which contributors who are unemployed shall be entitled under certain circumstances; and to provide that applications for unemployment benefits shall lapse if the contributors concerned fail to report and attend at certain places and times; and to provide for matters connected therewith.

(Assented to 13 October 1987.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 34 of Act 30 of 1966, as substituted by section 14 of Act 9 of 1979.

1. Section 34 of the Unemployment Insurance Act, 1966, is hereby amended by the addition of the following subsection:

5
“(10) (a) A contributor shall not be entitled to benefits unless he applies therefor in terms of this Act.”

(b) A contributor who, in any period of fifty-two consecutive weeks, has received benefits for twenty-six weeks or for the longer period referred to in section 35 (14) (a) or 36 (9) (a), shall not be entitled to receive any unemployment benefits in terms of section 35 or illness benefits in terms of section 36, unless he applies anew for such benefits in accordance with section 35 (2) or 36 (3), as the case may be.”

Amendment of section 35 of Act 30 of 1966, as substituted by section 15 of Act 9 of 1979 and amended by section 9 of Act 1 of 1982.

2. Section 35 of the Unemployment Insurance Act, 1966, is hereby amended—

(a) by the substitution for paragraph (b) of subsection (5) of the following paragraph:

“(b) The provisions of paragraph (a) shall apply also with reference to a contributor who is not entitled to benefits in terms of paragraph (e) or (f) of subsection (13) [and the claims officer may extend the period during which the contributor shall not be entitled to receive benefits by a period equal to the period during which the contributor failed to comply with the provisions of paragraph (a)].”; and

(b) by the addition to subsection (5) of the following paragraph:

“(c) If a contributor fails, without good cause, to report and attend at a place or at a time determined under paragraph (a), the application concerned for unemployment benefits shall lapse, and no further benefits shall be paid to him on account of that application.”.

WET

Tot wysiging van die Werkloosheidversekeringswet, 1966, ten einde met terugwerkende krag verdere voorsiening te maak met betrekking tot die voordele waarop bydraers wat werkloos is onder sekere omstandighede geregtig is; en te bepaal dat aansoek om werkloosheidvoordele verval indien die betrokke bydraers versum om hulle op sekere plekke en tye aan te meld; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 34 van die Werkloosheidversekeringswet, 1966, word hierby gewysig deur die volgende subartikel by te voeg:
5 “(10) (a) 'n Bydraer is nie op voordele geregtig nie tensy hy ingevolge hierdie Wet daarom aansoek doen.”
- (b) 'n Bydraer wat gedurende enige tydperk van twee-en-vyftig agtereenvolgende weke voordele vir ses-en-twintig weke of vir die langer tydperk bedoel in artikel 35 (14) (a) of 36 (9) (a) ontvang het, is nie geregtig om enige werkloosheidvoordele kragtens artikel 35 of siektevoordele kragtens artikel 36 te ontvang nie, tensy hy opnuut aansoek doen om sodanige voordele ooreenkomsdig artikel 35 (2) of 36 (3), na gelang van die geval.”.
- 10 2. Artikel 35 van die Werkloosheidversekeringswet, 1966, word hierby gewysig—
 (a) deur paragraaf (b) van subartikel (5) deur die volgende paragraaf te vervang:
 “(b) Die bepalings van paragraaf (a) is ook van toepassing met betrekking tot 'n bydraer wat ingevolge paragraaf (e) of (f) van subartikel (13) nie op voordele geregtig is nie [en die eisebeampte kan die tydperk waartydens die bydraer nie geregtig is om voordele te ontvang nie, verleng met 'n tydperk gelijk aan die tydperk waartydens die bydraer versum het om aan die bepalings van paragraaf (a) te voldoen].”; en
- 15 (b) deur subartikel (5) die volgende paragraaf te voeg:
 “(c) Indien 'n bydraer sonder grondige rede versum om hom aan te meld op 'n plek of op 'n tyd kragtens paragraaf (a) bepaal, verval die betrokke aansoek om werkloosheidvoordele en word geen verdere voordele op grond van daardie aansoek aan hom betaal nie.”.
