**Tot wysiging van die Boswet, 1984, ten einde die samestelling van die Bosbouraad te verander; en voorsiening te maak vir die betaling van besoldiging aan lede van die raad, komitees en werkgroep van die raad; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.**

**DAAR WORD BEPAAL** deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 49 van Wet 122 van 1984.

Vervanging van artikel 52 van Wet 122 van 1984.

Kort titel.

- 1.** Artikel 49 van die Boswet, 1984, word hierby gewysig—  
(a) deur paragraaf (a) van subartikel (2) deur die volgende paragraaf te vervang:  
“(a) Drie beampies van die departement [ , van wie een as voorstitter en een as ondervoerstitter deur die Minister aangewys moet word];” en  
(b) deur die volgende subartikel na subartikel (2) in te voeg:  
“(2A) Die Minister moet 'n lid van die raad as voorstitter van die raad en 'n ander sodanige lid as ondervoerstitter daarvan aanwys.”.
- 2.** Artikel 52 van die Boswet, 1984, word hierby deur die volgende artikel vervang:  
“Toelaes en besoldiging betaalbaar aan lede van die raad en sekere ander persone. **52. [Daar kan aan] Aan** 'n lid of plaasvervangende lid van die raad en **[aan]** 'n lid van 'n komitee of werkgroep van die raad wat nie in die heeltydse diens van die Staat is nie, **word** die toelaes en besoldiging uit die fonds betaal **[word]** wat die Minister in 10 die algemeen of in 'n besondere geval, na oorleg met die raad en in oorleg met die Minister van Finansies, bepaal.”.
- 3.** Hierdie Wet heet die Boswysigingswet, 1988.

## FOREST AMENDMENT ACT, 1988

## ACT

To amend the Forest Act, 1984, in order to change the constitution of the Forestry Council; to provide for the payment of remuneration to members of the council, committees and working groups of the council; and to provide for matters incidental thereto.

(Assented to 14 March 1988.)*

**BE IT ENACTED** by the State President and the Parliament of the Republic of South Africa, as follows:—

1. Section 49 of the Forest Act, 1984, is hereby amended—  
5           (a) by the substitution for paragraph (a) of subsection (2) of the following paragraph:  
               “(a) Three officers of the department **[, of whom one must be designated by the Minister as chairman and one as vice-chairman]**; and  
10           (b) by the insertion after subsection (2) of the following subsection:  
               “**(2A) The Minister shall designate a member of the council as chairman of the council and another such member as vice-chairman thereof.**”
2. The following section is hereby substituted for section 52 of  
15 the Forest Act, 1984:  
“Allowances and re-muneration payable to members of council and certain other persons.  
20           52. A member or alternate member of the council and a member of a committee or working group of the council who is not in the full-time employment of the State **[may be paid]** shall be paid from the fund such allowances and remuneration as the Minister may determine in general or in any particular case, after consultation with the council **and in consultation with the Minister of Finance.”**
3. This Act shall be called the Forest Amendment Act, 1988.
