ADDITIONAL APPROPRIATION ACT (HOUSE OF ASSEMBLY),
1988

Act No. 18, 1988

ACT

To appropriate additional amounts of money for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1988.

(Assented to 14 March 1988.)

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Appropriation of additional moneys for requirements of Administration: House of Assembly

- 5 1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1988, as a charge to the Revenue Account: House of Assembly, the additional amounts of money shown in column 1 of the Schedule.

10 Short title

2. This Act shall be called the Additional Appropriation Act (House of Assembly), 1988.
