Tot wysiging van die Wet op Diamante, 1986, om die omskrywing van "Minister" te vervang; en om die samestelling van die Suid-Afrikaanse Diamantraad te verander.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 56 van 1986

1. Artikel 1 van die Wet op Diamante, 1986, word hierby gewysig deur die omskrywing van "Minister" deur die volgende omskrywing te vervang— 5
"Minister" die Minister van **[Mineraal- en Energiesake]** Ekonommiese Sake en Tegnologie;"

Wysiging van artikel 5 van Wet 56 van 1986

2. Artikel 5 van die Wet op Diamante, 1986, word hierby gewysig—
- (a) deur paragraaf (e) van subartikel (1) deur die volgende paragraaf te 10
vervang:
"(e) **[een lid van die bestuursraad van die Vereniging van Diamantprodusente, uitgesonderd 'n lid in die diens van die Staat of deur hom aangestel, deur bedoelde Vereniging benoem]** twee persone wat òf produsente is òf na die oordeel van die Minister bevoeg is om die 15
produsente te verteenwoordig;" en
 - (b) deur paragraaf (f) van subartikel (1) te skrap.

DIAMONDS AMENDMENT ACT, 1988

Act No. 28, 1988

ACT

To amend the Diamonds Act, 1986, so as to substitute the definition of "Minister"; and to alter the constitution of the South African Diamond Board.

*(English text signed by the State President.)
(Assented to 21 March 1988.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 56 of 1986

1. Section 1 of the Diamonds Act, 1986, is hereby amended by the substitution for 5 the definition of "Minister" of the following definition:

"Minister" means the Minister of **[Mineral and Energy Affairs]** Economic Affairs and Technology;"

Amendment of section 5 of Act 56 of 1986

2. Section 5 of the Diamonds Act, 1986, is hereby amended—

10 (a) by the substitution for paragraph (e) of subsection (1) of the following paragraph:

15 "(e) **[one member of the management board of the Diamond Producers' Association, other than a member in the service of the State or appointed by it, nominated by such Association]** two persons who are either producers or in the opinion of the Minister are capable of representing the producers;"; and

(b) by the deletion of paragraph (f) of subsection (1).

Short title

3. This Act shall be called the Diamonds Amendment Act, 1988.
