ORDER UNDER THE SECURITY EMERGENCY REGULATIONS, 1988

Under the powers vested in me by regulation 10 of the Security Emergency Regulations, 1988, I, Hendrik Gideon de Witt, Commissioner of the South African Police, hereby prohibit during the period of 22 September 1988 to 25 September 1988, both dates included, in the Magisterial Districts of The Cape, Wynberg, Goodwood, Bellville, Kuils River or Simon's Town any gathering which is held under the banner "Anti-Apartheid Conference", including the gatherings which were organised to be held in the Conference Hall, Protea Room, Century Hotel, Sea Point, Cape Town, on 23 September 1988 and in the Jamieson Hall, University of Cape Town, on 24 September 1988.
