DECLARATION AS A TOLL ROAD OF THE HENDRIK SCHOEMAN EXPRESSWAY.—PROVINCE OF THE TRANSVAAL

In terms of section 9 (1) (a) and (2) of the National Roads Act, 1971 (Act 54 of 1971), as amended, the National Transport Commission, instituted in terms of section 3 of the Transport Co-ordination Act, 1948 (Act 44 of 1948), hereby declares that the following sections of existing national road shall be a toll road:

National Route 17 as declared by Government Notice 141 of 1985 (titled "City Deep-Dalpark") and Government Notice 1947 of 1987 (titled "Dalpark Township-Anchor Road"), and those portions of National Route 3/12, as declared by Proclamation 216 of 1982 (titled "Old Barn Interchange-Gillooly's Interchange"), consisting of Portion 421 (a portion of Portion 8), South Rand Road, Remainder of Portion 337 and Portion 418 (a portion of Portion 205) all of Elandsfontein 108 IR.

(Hendrik Schoeman Expressway, Districts of Johannesburg, Alberton, Germiston, Boksburg, Brakpan and Springs.)

Nasionale Roete 17 soos verklaar by Goewermenskennisgewing 141 van 1985 en genoem "City Deep-Dalpark" en Goewermenskennisgewing 1947 van 1987 en genoem "Dalpark-dorpsgebied-Anchorweg" en daardie gedeeltes van Nasionale Roete 3/12 soos verklaar by Proklamasie 216 van 1982 en genoem "Old Barnwisselaar-Gilloolyswisselaar", bestaande uit Gedeelte 421 ('n gedeelte van Gedeelte 8), Suidrandpad, Restant van Gedeelte 337 en Gedeelte 418 ('n gedeelte van Gedeelte 205) almal van Elandsfontein 108 IR.
