## GOVERNMENT NOTICE

### SOUTH AFRICAN RESERVE BANK

No. 2619

BANKS ACT, 1965 (ACT 23 of 1965)

**DIRECTION UNDER SECTION 9 OF THE BANKS ACT, 1965, IN RESPECT OF THE REPAYMENT OF CERTAIN MONEY OBTAINED FROM DEPOSITORS**

Under the powers vested in me by section 9 of the Banks Act, 1965 (Act 23 of 1965—hereinafter referred to as the Banks Act), I, Gerhardus Steenkamp, Deputy Registrar of Banks, hereby direct—

(1) that Eurobond (Ciskei) (Proprietary) Limited (hereinafter referred to as Eurobond), with principal place of business at Fourth Floor, Sanlam Plaza East, 285 Schoeman Street, Pretoria, shall repay to the depositors concerned all money obtained from depositors by it by carrying on the business of a banking institution without it having been registered or provisionally registered as required by the Banks Act or any law repealed by the Banks Act; and

(2) that the repayment to depositors in terms of paragraph (1) shall take place on Thursday, 15 December 1988, irrespective of the date on which such money would have become claimable in terms of any agreement between a depositor and Eurobond.

(2) dat die terugbetaling aan deposante ingevolge paragraaf (1) op Donderdag, 15 Desember 1988, moet plaasvind ongeag die datum waarop sodanige geld opeisbaar sou word ingevolge enige ooreenkoms tussen 'n deposant en Eurobond.
