

By means of direct subject indexing the retrieval of information on any subject is facilitated. Subjects are arranged alphabetically and subdivisions within each subject range from the general to the specific. Thus the user may either be directed to an individual notice or obtain an overview of existing legislation on a particular subject.

The Index is an especially valuable aid to the legal profession, local authorities, libraries, and commercial and industrial institutions.

It is published in three quarterly paperback issues and a hard cover annual cumulation. The subscription price is R96 p.a. (plus GST, postage and handling charges). Microfiche editions are available at the same price. A hard cover, two-volume **Cumulated Government Gazette Index (1979–1985)** is also obtainable at R150 (plus GST, postage and handling charges).
