**PROCEDURES AND CONDITIONS REGARDING THE EXEMPTION FROM THE SURCHARGE ON GOODS IMPORTED FOR RELIGIOUS PURPOSES**

In terms of a provision created under "Notes" in Part 4 of Schedule 1 to the Customs and Excise Act, 1964, goods may be imported by religious groups for religious purposes with exemption from the surcharge, subject to a permit issued by the Director-General of Trade and Industry on the recommendation of the Board of Trade and Industry. Religious groups who want to avail themselves of this concession must address their applications to the Chief Executive Officer, Board of Trade and Industry, Private Bag X753, Pretoria, 0001.

**PROSEDURES EN VOORWAARDES MET BETREKKING TOT DIE VRYSTELLING VAN BOBELASTING OP GOEDERE INGEVOER VIR GODSDIENSTIGE DOELEINDES**

Ingevolge 'n voorsiening onder "Opmerkings" in Deel 4 van Bylae 1 by die Doeane- en Aksynswet, 1964, geskep, kan goedere vir godsdienstige doeleindes met vrystelling van die bobelasting deur godsdienstige groepe ingevoer word onderworpe aan 'n permit uitgereik deur die Directeur-generaal van Handel en Nywerheid op aanbeveling van die Raad van Handel en Nywerheid. Godsdienstige groepe wat van die toegewing gebruik wil maak, moet hulle aansoek rig aan die Hoof Uitvoerende Beampete, Raad van Handel en Nywerheid, Privaatsak X753, Pretoria, 0001.

The following procedures and conditions apply to such imports:

- (1) Permits will be issued only to institutions nominated by the religious group concerned;
- (2) the religious group must demonstrate to the satisfaction of the Board that efforts have been made to obtain the goods locally, but that they are not satisfactorily available locally;
- (3) the permits will be for a limited period only and will be linked to one nominated religious occasion per annum;
- (4) the products concerned must be essential to do justice to the character of the religious occasion;
- (5) the religious organisation concerned must apply annually in advance to the Board for the permits and must advise the Board of the products and the f.o.b. value of each product for which the permits are to be issued and of the institutions in favour of whom the permits should be issued and the Board reserves the right to amend the value figure and to exclude specific products, according to circumstances;
- (6) each religious group must accept responsibility both for controlling the system and for assisting the Customs and Excise authorities to identify the products and administer the system; and
- (7) should it emerge that it is not possible to exercise the necessary control or that abuses have taken place, the rebate provision will be withdrawn.

- (5) die betrokke godsdienstige organisasie moet jaarliks vooruit by die Raad aansoek doen om die permitte en moet die Raad in kennis stel van die produkte en die v.a.b.-waarde van elke produk waarvoor die permitte uitgereik moet word, asook van die instansies aan wie die permitte uitgereik moet word, en die Raad behou hom die reg voor om die waarde te wysig en om spesifieke produkte weg te laat na gelang van omstandighede;
- (6) elke godsdienstige groep moet verantwoordelikheid aanvaar vir die kontrolering van die stelsel en moet die Doeane- en Aksynsowerheid bystaan om die produkte te identifiseer en die stelsel te administreer; en
- (7) indien dit sou blyk dat dit nie moontlik is om die nodige beheer uit te oefen nie of dat misbruik plaasvind, sal die kortingvoorsiening ingetrek word.
