Act No. 5, 1989

ADDITIONAL APPROPRIATION ACT, 1989

ACT

To appropriate an additional amount of money for the requirements of the State in respect of the financial year ending 31 March 1989.

*(English text signed by the acting State President.)
(Assented to 27 February 1989.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Appropriation of additional amounts of money for requirements of State, excluding provinces

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the State, excluding the provinces, in respect of the financial year ending 31 March 1989, as a charge to the State Revenue Account, the additional amounts of money shown in column 1 of Schedule 1.

Appropriation of additional amounts of money for requirements of province of the 10 Cape of Good Hope

2. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of the Cape of Good Hope in respect of the financial year ending 31 March 1989, as a charge to the Account for Provincial Services: Cape, 15 the additional amounts of money shown in column 1 of Schedule 2.

Appropriation of additional amounts of money for requirements of province of Natal

3. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of Natal in respect of the financial year ending 31 20 March 1989, as a charge to the Account for Provincial Services: Natal, the additional amounts of money shown in column 1 of Schedule 3.

Appropriation of additional amounts of money for requirements of province of the Orange Free State

4. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of the Orange Free State in respect of the financial year ending 31 March 1989, as a charge to the Account for Provincial Services: Orange Free State, the additional amounts of money shown in column 1 of Schedule 4.

Appropriation of additional amounts of money for requirements of province of the 30 Transvaal

5. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of the Transvaal in respect of the financial year ending 31 March 1989, as a charge to the Account for Provincial Services: Transvaal, the 35 additional amounts of money shown in column 1 of Schedule 5.
