ACT

To appropriate additional amounts of money for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1989.

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

Appropriation of additional moneys for requirements of Administration: House of Representatives

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1989, as a charge to the Revenue Account: House of Representatives, the additional amounts of money shown in column 1 of the Schedule.
