PUBLICATIONS OR OBJECTS.—EXEMPTION FROM SECTION 9 (4)

A Committee referred to in section 4 of the Publications Act, 1974 (the Act), has in terms of section 11 (2) of the Act decided that the undermentioned publication which is published by the **Informationsstelle Südliches Afrika, Bonn** is not undesirable within the meaning of section 47 (2) of the Act while the importation of all publications published by this publisher has been prohibited under section 9 (4) of the Act.

With regard to this particular publication the Directorate of Publications hereby grants exemption from section 9 (4) of the Act to persons who wish to import and possess it.
