ACT

To amend the Housing Development Schemes for Retired Persons Act, 1988, so as to amend the definition of "housing development scheme"; to provide that land subject to a housing interest may be occupied only by a retired person or the spouse of a retired person; and to repeal section 10 of the Act; and to provide for incidental matters.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 65 of 1988

1. Section 1 of the Housing Development Schemes for Retired Persons Act, 1988 (hereinafter referred to as the principal Act), is hereby amended by the substitution for paragraph (a) of the definition of "housing development scheme" of the following paragraph:

"(a) in terms of which housing interests are alienated [or are offered for alienation, only to retired persons or mainly to such persons] for occupation contemplated in section 7, whether the scheme, arrangement or undertaking is operated pursuant to or in connection with a development scheme or a share block scheme or membership of or participation in any club, association, organization or other body, or the issuing of shares, or otherwise, but excluding a property time-sharing scheme; or".

Substitution of section 7 of Act 65 of 1988

2. The following section is hereby substituted for section 7 of the principal Act:

"Limitation of occupation of land to which housing interest relates

(1) After a housing interest has been transferred to or has otherwise been vested in a [retired] person by virtue of a contract, no person [shall alienate that interest to any person] other than a retired person or the spouse of a retired person may occupy the land to which that housing interest relates, except with the written consent of all the holders of housing interests in the housing development scheme concerned.

(2) Any person who contravenes subsection (1) shall be guilty of an offence and liable on conviction to a fine not exceeding R1 000 or to 25

Tot wysiging van die Wet op Behuisingsontwikkelingskemas vir Afgetrede Persone, 1988, ten einde die omskrywing van "behuisingsontwikkelingskema" te wysig; voorsiening te maak dat grond wat aan 'n behuisingsbelang onderworpe is slegs deur 'n afgetrede persoon of die gade van 'n afgetrede persoon geokkupeer mag word; en artikel 10 van die Wet te herroep; en om vir bykomstige aangeleenthede voorsiening te maak.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 65 van 1988

1. Artikel 1 van die Wet op Behuisingsontwikkelingskemas vir Afgetrede Persone, 5 1988 (hieronder die Hoofwet genoem), word hierby gewysig deur paragraaf (a) van die omskrywing van "behuisingsontwikkelingskema" deur die volgende paragraaf te vervang:

10 "(a) waarvolgens behuisingsbelange vervreem word **[of vir vervreemding aangebied word, slegs aan afgetrede persone of hoofsaaklik aan sodanige persone]** vir okkupasie in artikel 7 beoog, hetby die skema, reëling of onderneming bedryf word uit hoofde van of in verband met 'n ontwikkelingskema of 'n aandeleblokskema of lidmaatskap van of deelname aan enige klub, vereniging, organisasie of ander liggaam, of die uitreiking van aandele, of andersins, maar uitgesonderd 'n eiendomstydsklassekema; of".

Vervanging van artikel 7 van Wet 65 van 1988

2. Artikel 7 van die Hoofwet word hierby deur die volgende artikel vervang:

“Beperking op okkupasie van grond waarop behuisingsbelang betrekking het

20 (1) Nadat 'n behuisingsbelang uit hoofde van 'n kontrak aan 'n **[afgetrede]** persoon oorgedra of op 'n ander wyse in hom gevestig is, mag niemand **[daardie belang aan iemand anders as]** behalwe 'n afgetrede persoon **[vervreem nie]** of die gade van 'n afgetrede persoon die grond waarop daardie behuisingsbelang betrekking het, okkupeer nie, behalwe met die skriftelike toestemming van al die houers van behuisingsbelange in die betrokke behuisingsontwikkelingskema.

25 (2) Enigiemand wat subartikel (1) oortree, is skuldig aan 'n misdryf en by skuldigbevinding strafbaar met 'n boete van hoogstens R1 000 of met

imprisonment for a period not exceeding six months or to both that fine and that imprisonment.”.

Repeal of section 10 of Act 65 of 1988

3. Section 10 of the principal Act is hereby repealed.

4. This Act shall be called the Housing Development Schemes for Retired Persons Amendment Act, 1989.
