COAL ACT, 1983 (ACT No. 32 OF 1983)

### NOTICE OF LEVY ON COAL

I, George Shepstone Bartlett, Deputy Minister of Economic Affairs and Technology, acting on behalf of, and in pursuance of an assignment by the Minister of Economic Affairs and Technology, hereby inform each colliery, which produced not less than 10 000 metric tons of coal during the preceding calendar year, in terms of section 8 (1) (a) of the Coal Act, 1983 (Act No. 32 of 1983), as amended, that I, with the concurrence of the Minister of Finance, impose a levy of 2,275 cents per metric ton on all coal sold or used for any industrial purpose (other than for the production of coal at the colliery in question) by the relevant colliery during such calendar year.
