SECURITY OFFICERS ACT, 1987

APPOINTMENT OF MEMBERS TO THE SECURITY OFFICERS' BOARD

Under the powers vested in me by section 4 (4) (a) of the Security Officers Act, 1987 (Act No. 92 of 1987), I, Hendrik Gideon de Witt, Commissioner of the South African Police, hereby invite persons rendering security services and associations and organizations of security officers, for the purpose of appointing persons referred to in section 4 (1) (a) of the said Act as members of the Security Officers' Board, to submit to me during the period commencing on 3 April 1989 to 15 May 1989 in accordance with the format in the accompanying Schedule (directly or through any federation of such associations or organizations) names of persons who have pursued the occupation of security officer for at least seven years and who are competent and fit and proper, to be appointed as members contemplated in section 4 (1) (a).

Proposals should be forwarded in writing to the Commissioner of the South African Police, Private Bag X267, Pretoria, and be accompanied by documentation incorporating the following particulars, namely:

- (1) A *curriculum vitae* of the nominee giving full particulars of all educational qualifications, particularly those pertinent to the security industry.
- (2) Particulars of experience in the security industry showing dates of commencement/termination of service and job responsibility.
