## GOVERNMENT NOTICE

### SOUTH AFRICAN POLICE

28 April 1989

#### ORDER UNDER THE SECURITY EMERGENCY REGULATIONS, 1988

Under the powers vested in me by regulation 10 of the Security Emergency Regulations, 1988, I, Hendrik Christoffel Müller, Divisional Commissioner of the South African Police for the Witwatersrand Division, hereby prohibit, in the area known as Alexandra Black Township—

- (a) the gathering organized and advertised to be held at the East Bank Community Hall on 30 April 1989, under the banner of a "CELEBRATION SERVICE" and
- (b) any other gathering which has been or is being or may be organized or advertised—
  - (i) as a gathering to welcome one or more of the persons specified in the Schedule; or
  - (ii) as a gathering in respect of which it is intimated that one or more of the persons specified in the Schedule, shall be present.

In this Order a word to which a meaning has been assigned in the Security Emergency Regulations, 1988, shall have the same meaning and "ALEXANDRA BLACK TOWNSHIP" means the area in the Magisterial District of Randburg known as Alexandra Black Township, as demarcated and described in Government Notices Nos. 9 of 24 January 1964; 64 of 22 March 1968; 1616 of 17 September 1971; 1830 of 8 October 1971 and 1656 of 15 August 1980.

#### BEVEL KRAGTENS DIE VEILIGHEIDS- NOODREGULASIES, 1988

Kragtens die bevoegdheid my verleen by regulasie 10 van die Veiligheidsnoodregulasies, 1988, verbied ek, Hendrik Christoffel Müller, Afdelingskommissaris van die Suid-Afrikaanse Polisie vir die Afdeling Witwatersrand, hierby, in die gebied bekend as Alexandra Swart woongebied—

- (a) die byeenkoms wat gereël of geadverteer is om gehou te word in die "EAST BANK COMMUNITY HALL" op 30 April 1989, onder die vaandel van 'n "CELEBRATION SERVICE"; en
- (b) enige ander byeenkoms wat gereël of geadverteer is of word of mag word—
  - (i) as 'n verwelkomingsbyeenkoms vir een of meer van die persone in die Bylae vermeld; of
  - (ii) as 'n byeenkoms ten opsigte waarvan te kenne gegee word dat een of meer van die persone in die Bylae vermeld, teenwoordig sal wees.

In hierdie Bevel het 'n woord waaraan 'n betekenis in die Veiligheidsnoodregulasies, 1988, geheg is, dieselfde betekenis en "ALEXANDRA SWART WOONGBIED" beteken die gebied in die landdrostdistrik van Randburg bekend as Alexandra Swart woongebied, soos afgebaken en omskryf in Goewermenskennisgewings Nos. 9 van 24 Januarie 1964; 64 van 22 Maart 1968; 1616 van 17 September 1971; 1830 van 8 Oktober 1971 en 1656 van 15 Augustus 1980.
