SOUTH AFRICAN TOURISM BOARD AMENDMENT ACT, 1989

GENERAL EXPLANATORY NOTE:

ACT

To amend the South African Tourism Board Act, 1983, so as to alter the constitution of the board; and to provide for matters connected therewith.

*(English text signed by the State President.)
(Assented to 17 May 1989.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 3 of Act 100 of 1983

1. The following section is hereby substituted for section 3 of the South African Tourism Board Act, 1983: 5

“Constitution of board

3. (1) The board consists of **[13 members appointed by the Minister in terms of subsection (2).]**

(2) The Minister shall appoint as members of the board—

- (a) nine persons who in his opinion have knowledge or experience of the tourist industry or of any branch or aspect thereof, or whom he considers suitable to serve as members of the board;
- (b) three persons in the full-time employment of the State to represent those departments of State designated by him;
- (c) one person, after consultation with such organization or organizations as he may deem fit.

(3) (a) Five of the persons mentioned in subsection (2) (a) shall be chosen by the Minister from a list of the names of persons nominated by such organization or organizations as he may from time to time designate as being representative of the tourist industry.

(b) When such a person is to be appointed, the Minister shall request that organization or, if more than one has been designated, each of those organizations to submit to him within a specified period a list of the names of a stated number of persons regarded by the organization concerned as suitable for appointment.

(c) If such a list is not submitted to the Minister within the specified period or does not contain the names of the stated number of persons or does not contain the names of a sufficient number of persons who are in his opinion suitable for appointment, he shall, with due regard to the provisions of subsection (2) (a), appoint the requisite number of persons] so many members as the Minister may from time to time determine by notice in the *Gazette*, and its members shall be appointed by the Minister in consultation with the Chairmen of the Ministers' Councils of the respective Houses of Parliament.

Tot wysiging van die Wet op die Suid-Afrikaanse Toerismeraad, 1983, ten einde die samestelling van die raad te verander; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatpresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 3 van Wet 100 van 1983

1. Artikel 3 van die Wet op die Suid-Afrikaanse Toerismeraad, 1983, word hierby
5 deur die volgende artikel vervang:

"Samestelling van raad"

3. (1) Die raad bestaan uit **[13 lede wat ingevolge subartikel (2) deur die Minister aangestel is.]**

(2) Die Minister moet as lede van die raad aanstel—

(a) nege persone wat na sy oordeel kennis of ondervinding van die toerismebedryf of van 'n vertakkiging of aspek daarvan het, of wat hy geskik ag om as lede van die raad te dien;

(b) drie persone in die voltydse diens van die Staat om dié Staatsdepartemente te verteenwoordig wat hy aanwys;

(c) een persoon, na oorlegpleging met dié organisasie of organisasies wat hy goedvind.

(3) (a) Vyf van die persone vermeld in subartikel (2) (a) moet deur die Minister gekies word uit 'n lys van name van persone genomineer deur dié organisasie of organisasies wat hy van tyd tot tyd as verteenwoordigend van die toerismebedryf mag aanwys.

(b) Wanneer so 'n persoon aangestel moet word, moet die Minister daardie organisasie of, as daar meer as een aangewys is, elk van daardie organisasies versoek om binne 'n vermelde tydperk 'n lys van die name van 'n aangeduide getal persone wat deur die betrokke organisasie as geskik vir aanstelling beskou word, aan hom voor te lê.

(c) Indien so 'n lys nie binne die vermelde tydperk aan die Minister voorgelê word nie of nie die name van die aangeduide getal persone bevat nie of nie die name van 'n voldoende getal persone bevat wat na sy oordeel geskik vir aanstelling is nie, moet hy, met inagneming van die bepalings van subartikel (2) (a), die nodige getal persone aanstel] die getal lede wat die Minister van tyd tot tyd by kennisgewing in die Staatskoerant bepaal, en sy lede word deur die Minister aangestel in oorleg met die Voorsitters van die Ministersrade van die onderskeie Huise van die Parlement.

[(4)] (2) A member of the board holds office for such period, but not exceeding three years, and on such conditions as the Minister may determine at the time of his appointment: Provided that a member may be reappointed at the expiry of his term of office.”.

Short title and commencement

5

2. This Act shall be called the South African Tourism Board Amendment Act, 1989, and shall come into operation on a date fixed by the State President by proclamation in the *Gazette*.

5 Kort titel en inwerkingtreding

2. Hierdie Wet heet die Wysigingswet op die Suid-Afrikaanse Toerismeraad, 1989, en tree in werking op 'n datum wat die Staatspresident by proklamasie in die *Staatskoerant* bepaal.
