## WARRANT

by the State President of the Republic of South Africa by which "The South African Police Cross for Bravery—Die Suid-Afrikaanse Polisiekruis vir Dapperheid" is instituted

To all to whom these presents shall come:

Greetings!

Whereas it is deemed desirable to recognise single acts of valour displayed by members of the South African Police who, in the discharge of their functions or in protecting or saving property or life, have lost or genuinely imperilled their own lives;

And whereas it is deemed expedient to honour such members in a fitting manner;

Now, therefore, in terms of section 22 (2) of the Police Act, 1958 (Act No. 7 of 1958), I repeal the Warrant dated 20 May 1963 as promulgated in *Government Gazette* No. 547, dated 5 July 1963 and the Rules thereto without prejudice to anything lawfully done thereunder;

And now, therefore, in terms of section 22 (2) of the Police Act, 1958 (Act No. 7 of 1958), I do hereby institute a *new decoration* in recognition of acts of outstanding and exceptional bravery by members of the South African Police and further ordain that the following *Rules* as may be made under this Warrant, shall govern the award of the *Decoration*:

### 1. PRECEDENCE:

The decoration shall have precedence over any other decoration or medal which may be awarded exclusively to members of the South African Police.

Aan almal wat hiervan kennis mag neem:

Saluut!

Nademaal dit wenslik geag word om uitnemende heldemoed aan die dag gelê deur lede van die Suid-Afrikaanse Polisie, wat by die vervulling van hul werkzaamhede of beskerming of redding van eiendom of lewe hul eie lewens verloor of werklik in gevaar gestel het, te erken;

En nademaal dit dienstig geag word om sodanige lede op 'n gepaste wyse te vereer;

So is dit dat ek kragtens artikel 22 (2) van die Polisiewet, 1958 (Wet No. 7 van 1958), die Bevelskrif, gedateer 20 Mei 1963 soos aangekondig by *Staatskoerant* No. 547, gedateer 5 Julie 1963 en die Reëls daarby herroep sonder om afbreuk te doen aan enigsies wat regtens daarkragtens verrig is;

En so is dit dat ek kragtens artikel 22 (2) van die Polisiewet, 1958 (Wet No. 7 van 1958), hierby 'n *nuwe dekorasie* instel ter erkenning van dade van uitnemende en buitengewone dapperheid deur lede van die Suid-Afrikaanse Polisie aan die dag gelê en voorts verorden dat die onderstaande *Reëls* wat ingevolge hierdie Bevelskrif uitgevaardig mag word, vir die toekenning van die *Dekorasie* geld:

### 1. VOORRANG:

Die dekorasie het voorrang bo enige ander dekorasie of medalje wat uitsluitlik aan lede van die Suid-Afrikaanse Polisie toegeken kan word.

## 2. CATEGORIES OF AWARDS:

The South African Police Cross for Bravery includes the following in order of seniority:

(1) The South African Police Cross for Bravery (Gold) which may be awarded to members of the South African Police who have distinguished themselves by *performing outstanding deeds of bravery in extremely dangerous circumstances.*

(2) The South African Police Cross for Bravery (Silver) which may be awarded to members of the South African Police who have distinguished themselves by *performing exceptional deeds of bravery in very dangerous circumstances.*

(3) The South African Police Cross for Bravery which may be awarded to members of the South African Police who have distinguished themselves by *performing deeds of bravery in dangerous circumstances.*

## 3. HERALDIC DESCRIPTION OF THE DECORATION:

(1) The South African Police Cross for Bravery (Gold) shall consist of a four-limbed gold cross with a cross-shaped gold clevis. The size of the decoration shall be such as to permit of a circle with a diameter of 25 mm enclosing the limbs of the cross. Each limb shall consist of a series of five superimposed planes of varying size, slanting upwards to the centre of the uppermost plane where it forms a ridge. On the obverse, in the centre of the cross, shall be mounted an enamel medallion on which shall be depicted a laurel of gold-defined green leaves enclosing a circular gold-edged royal blue band, on a white background, with the words "VIVIT POST FUNERA VIRTUS", embossed on the band in capital letters of gold; the circle enclosed by the band being divided into eight symmetrical facets with four valleys and four gold-defined ridges which gradually rise to an apex so that the ridges form a right-angled cross with horizontal and vertical limbs. The reverse of the decoration shall depict in relief, the coat of arms of the Republic of South Africa with the words "VIR DAPPERHEID" and "FOR BRAVERY", in capital letters as circumscription; the former on the heraldic dexter and the latter on the heraldic sinister side.

(2) The South African Police Cross for Bravery (Silver) shall consist of a four-limbed silver cross with a cross-shaped silver clevis. The size of the decoration shall be such as to permit of a circle with a diameter of 25 mm enclosing the limbs of the cross. Each limb shall consist of a series of five superimposed planes of varying size, slanting upwards to the centre of the uppermost plane where it forms a ridge. On the obverse, in the centre of the cross, shall be mounted an enamel medallion on which shall be depicted a laurel of silver-defined green leaves enclosing a circular silver-edged royal blue band, on a white background, with the words "VIVIT POST FUNERA VIRTUS", embossed on the band in capital letters of silver; the circle enclosed by the band being divided into eight symmetrical facets with four valleys and four silver-defined ridges which gradually rise to an apex so that the ridges form a right-angled cross with horizontal and vertical limbs. The reverse of the decoration shall depict in relief, the coat of arms of the Republic of South Africa with the words "VIR DAPPERHEID" and "FOR BRAVERY", in capital letters as circumscription; the former on the heraldic dexter and the latter on the heraldic sinister side.

## 2. GRADE VAN TOEKENNING:

Die Suid-Afrikaanse Polisiekruis vir Dapperheid behels die volgende in orde van senioriteit:

(1) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Goud) wat toegeken kan word aan lede van die Suid-Afrikaanse Polisie wat hulle onderskei het deur *in uiterste lewensgevaar uitnemende dade van dapperheid te verrig.*

(2) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Silwer) wat toegeken kan word aan lede van die Suid-Afrikaanse Polisie wat hulle onderskei het deur *in groot lewensgevaar buitengewone dade van dapperheid te verrig.*

(3) Die Suid-Afrikaanse Polisiekruis vir Dapperheid wat toegeken kan word aan lede van die Suid-Afrikaanse Polisie wat hulle onderskei het deur *lewensgevaar dade van dapperheid te verrig.*

## 3. HERHALDIESE OMSKRYWING VAN DIE DEKORASIE:

(1) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Goud) bestaan uit 'n vierarmige goue kruis met 'n kruisvormige goue beuel. Die grootte van die dekorasie is sodanig dat die kruisarms deur 'n sirkel met 'n deursnee van 25 mm omsluit kan word. Elke arm bestaan uit 'n reeks van vyf ooreenliggende vlakke van wissellende grootte wat skuins oploop na die middel van die boonste vlak waar dit 'n rif vorm. Op die voor-kant, in die middel van die kruis, is 'n emaljemedaljon gemonteer waarop 'n lourierkrans van goudomlynde groen blare uitgebeeld word wat 'n sirkelvormige goudomlynde koningsblou band, teen 'n wit agtergrond, met die woorde "VIVIT POST FUNERA VIRTUS", in verhewe goue hoofletters op die band, omvleuel; die sirkel wat deur die band omsluit word, is verdeel in agt simmetriese fasette met vier kiele en vier goudbelynde nokke wat geleidelik na 'n toppunt styg sodat die nokke 'n reghoekige kruis met horisontale en vertikale arms vorm. Op die keersy van die dekorasie word in reliëf uitgebeeld die wapen van die Republiek van Suid-Afrika met die woorde "VIR DAPPERHEID" en "FOR BRAVERY", in hoofletters, in randskrif, eersgenoemde aan die heraldiese regter- en laasgenoemde aan die heraldiese linkerkant.

(2) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Silwer) bestaan uit 'n vierarmige silwerkruis met 'n kruisvormige silwerbeuel. Die grootte van die dekorasie is sodanig dat die kruisarms deur 'n silkel met 'n deursnee van 25 mm omsluit kan word. Elke arm bestaan uit 'n reeks van vyf ooreenliggende vlakke van wisselende grootte wat skuins oploop na die middel van die boonste vlak waar dit 'n rif vorm. Op die voor-kant, in die middel van die kruis, is 'n emaljemedaljon gemonteer waarop 'n lourierkrans van silweromlynde groen blare uitgebeeld word wat 'n sirkelvormige silweromlynde koningsblou band, teen 'n wit agtergrond, met die woorde "VIVIT POST FUNERA VIRTUS", in verhewe silwer hoofletters op die band, omvleuel; die sirkel wat deur die band omsluit word, is verdeel in agt simmetriese fasette met vier kiele en vier silverbelynde nokke wat geleidelik na 'n toppunt styg sodat die nokke 'n reghoekige kruis met horisontale en vertikale arms vorm. Op die keersy van die dekorasie word in reliëf uitgebeeld die wapen van die Republiek van Suid-Afrika met die woorde "VIR DAPPERHEID" en "FOR BRAVERY", in hoofletters, in randskrif, eersgenoemde aan die heraldiese regter- en laasgenoemde aan die heraldiese linkerkant.

(3) The South African Police Cross for Bravery shall consist of a four-limbed lower grade silver cross with a cross-shaped lower grade silver clevis. The size of the decoration shall be such as to permit of a circle with a diameter of 25 mm enclosing the limbs of the cross. Each limb shall consist of a series of five superimposed planes of varying size, slanting upwards to the centre of the uppermost plane where it forms a ridge. On the obverse, in the centre of the cross, shall be mounted an enamel medallion on which shall be depicted a laurel of lower grade silver-defined green leaves enclosing a circular lower grade silver-edged royal blue band, on a white background, with the words "VIVIT POST FUNERA VIRTUS", embossed on the band in capital letters of lower grade silver; the circle enclosed by the band being divided into eight symmetrical facets with four valleys and four lower grade silver-defined ridges which gradually rise to an apex so that the ridges form a right-angled cross with horizontal and vertical limbs. The reverse of the decoration shall depict in relief, the coat of arms of the Republic of South Africa with the words "VIR DAPPERHEID" and "FOR BRAVERY", in capital letters as circumscription; the former on the heraldic dexter and the latter on the heraldic sinister side.

#### 4. THE RIBBON

(1) The South African Police Cross for Bravery (Gold) shall be pendent from a royal blue ribbon, 32 mm wide, with a vertical old gold stripe, 4 mm wide, in the centre and on each side of the old gold stripe, a vertical white stripe, 2 mm wide.

(2) The South African Police Cross for Bravery (Silver) shall be pendent from a ribbon, 32 mm wide, with nine vertical royal blue, white, royal blue, white, old gold, white, royal blue, white and royal blue stripes respectively 8, 2, 2, 2, 4, 2, 2, 2 and 8 mm wide, in that sequence from left to right.

(3) The South African Police Cross for Bravery shall be pendent from a ribbon 32 mm wide, with thirteen vertical royal blue, white, royal blue, white, royal blue, white, old gold, white, royal blue, white, royal blue, white and royal blue stripes, respectively 4, 2, 2, 2, 2, 2, 4, 2, 2, 2, 2 and 4 mm wide in that sequence from left to right.

#### 5. THE BAR

The bar to the decoration which may be awarded in terms of Rule 7 shall, as the case may be, be of gold, silver or lower grade silver, 35 mm in length and 6 mm wide, embossed in the centre with a clasp in the form of a cross. In respect of each bar awarded a gold, silver or lower grade silver clasp answering to the foregoing description, shall be issued.

#### 6. CONFERMENT REQUIREMENTS

(1) The South African Police Cross for Bravery (Gold) which may be awarded to a member of the South African Police who has distinguished himself by performing an outstanding deed of bravery in extremely dangerous circumstances.

(2) The South African Police Cross for Bravery (Silver) which may be awarded to a member of the South African Police who has distinguished himself by performing an exceptional deed of bravery in very dangerous circumstances.

(3) The South African Police Cross for Bravery which may be awarded to a member of the South African Police who has distinguished himself by performing a deed of bravery in dangerous circumstances.

(3) Die Suid-Afrikaanse Polisiekruis vir Dapperheid bestaan uit 'n vierarmige laergraadsilwerkruis met 'n kruisvormige laergraadsilwerbeuel. Die grootte van die dekorasie is sodanig dat die kruisarms deur 'n sirkel met 'n deursnee van 25 mm omsluit kan word. Elke arm bestaan uit 'n reeks van vyf ooreenliggende vlakke van wisselende grootte wat skuins oploop na die middel van die boonste vlak waar dit 'n rif vorm. Op die voor-kant, in die middel van die kruis, is 'n emaljemedaljon gemonteer waarop 'n lourierkrans van laergraadsilweromlynde groen blare uitgebeeld word wat 'n sirkelvormige laergraadsilweromlynde koningsblou band, teen 'n wit agtergrond, met die woorde "VIVIT POST FUNERA VIRTUS", in verhewe laergraadsilwerhoofletters op die band, omvleuel; die sirkel wat deur die band omsluit word, is verdeel in agt simmetriese fasette met vier kiele en vier laergraadsilwerbelynde nokke wat geleidelik na 'n toppunt styg sodat die nokke 'n reghoekige kruis met horisontale en vertikale arms vorm. Op die keersy van die dekorasie word in reliëf uitgebeeld die wapen van die Republiek van Suid-Afrika met die woorde "VIR DAPPERHEID" en "FOR BRAVERY", in hoofletters, in randskrif, eersgenoemde aan die heraldiese regter- en laas-genoomde aan die heraldiese linkerkant.

#### 4. DIE LINT:

(1) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Goud) hang aan 'n koningsblou 32 mm-breë lint, met 'n vertikale ou-goud streep, 4 mm breed, in die middel. Aan weerskante van die ou-goud streep is 'n vertikale wit streep, 2 mm breed.

(2) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Silwer) hang aan 'n 32 mm-breë lint, met nege vertikale strepe van koningsblou, wit, koningsblou, wit, ou-goud, wit, koningsblou, wit en koningsblou, van links na regs, en onderskeidelik 8, 2, 2, 2, 4, 2, 2, 2 en 8 mm breed.

(3) Die Suid-Afrikaanse Polisiekruis vir Dapperheid hang aan 'n 32 mm-breë lint, met dertien vertikale strepe van koningsblou, wit, koningsblou, wit, koningsblou, wit, ou-goud, wit, koningsblou, wit, koningsblou, wit en koningsblou, van links na regs, en onderskeidelik 4, 2, 2, 2, 2, 4, 2, 2, 2, 2 en 4 mm breed.

#### 5. DIE BALK:

Die balk by die dekorasie wat kragtens reël 7 toegeken kan word, is na gelang van die geval van goud, silwer of laergraadsilwer, 35 mm lank en 6 mm breed, met in die middel daarvan 'n geëmbosseerde gespe in die vorm van 'n kruis. 'n Goue, silwer- of laergraadsilwergespe wat ooreenstem met die voorafgaande beskrywing, word uitgereik ten opsigte van elke balk wat toegeken word.

#### 6. TOEKENNINGSVEREISTES:

(1) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Goud) kan toegeken word aan 'n lid van die Suid-Afrikaanse Polisie wat hom onderskei het deurdat hy in uiterste lewensgevaar 'n uitnemende daad van dapperheid verrig het.

(2) Die Suid-Afrikaanse Polisiekruis vir Dapperheid (Silwer) kan toegeken word aan 'n lid van die Suid-Afrikaanse Polisie wat hom onderskei het deurdat hy in groot lewensgevaar 'n buitengewone daad van dapperheid verrig het.

(3) Die Suid-Afrikaanse Polisiekruis vir Dapperheid kan toegeken word aan 'n lid van die Suid-Afrikaanse Polisie wat hom onderskei het deurdat hy in lewensgevaar 'n daad van dapperheid verrig het.

## 7. CONFERMENT REQUIREMENTS RELATING TO A BAR:

A bar may be awarded to any person to whom the decoration has already been awarded and who, subsequent to such award and while still serving as a member of the South African Police, has again distinguished himself in the manner described in Rule 6. In respect of every such additional distinction an additional bar may be awarded: Provided that a gold, silver or lower grade silver bar shall be awarded only to a member who is in possession of a corresponding decoration. Otherwise an appropriate decoration shall be awarded and not a bar.

## 8. CONFERMENT, FORFEITURE OR RESTORATION OF DECORATION:

The decoration, as well as the bar in respect thereof, shall be awarded by the State President of the Republic of South Africa and may also be cancelled, annulled, declared forfeited or restored by the State President.

## 9. POSTHUMOUS AWARD:

The decoration as well as the bar in respect thereof may be awarded posthumously.

## 10. ENGRAVING/STAMPING OF DECORATION:

On the reverse of each decoration awarded shall be stamped/engraved the Force number, rank and name of the person who has been awarded the distinction.

## 11. PUBLISHING IN FORCE ORDERS AND RECORDING IN REGISTER:

The names of the members to whom the decoration or bar is awarded, shall be published in the South African Police Force Orders and shall, together with such particulars as the Commissioner of the South African Police may deem fit, be recorded in a register kept in his office.

12. The provisions of Rule 11 shall *mutatis mutandis* apply in respect of the cancellation, annulment, forfeiture and restoration of a decoration or bar.

13. The decoration shall be worn on the left breast and a bar in respect thereof shall be affixed to the ribbon. When the decoration is not worn, only the ribbon in respect thereof shall be worn on the left breast, and where the bar has been awarded, the clasp shall be affixed to the ribbon as an indication of the award of such bar.

14. The award of the decoration or bar shall not entitle the recipient to any individual precedence, but shall allow him to add the letters "PCFG", the abbreviation for "PRAEFECTURAE CRUX FORTITUDINIS (GOLD)", or "PCFS" if the decoration has been awarded in silver, or "PCF" if the award has been awarded in the lowest grade, after his name: Provided that only the letters attached to the higher decoration shall be used, whether a lower or higher decoration was awarded first.

15. A reproduction of the decoration in miniature, half the size of the decoration, may be worn on fitting occasions.

16. A sealed model of each decoration, as well as the bar and ribbon in respect thereof and of the miniature reproduction thereof, shall be kept in safe custody in the office of the Commissioner of the South African Police or in such other place as the State President of the Republic of South Africa may determine.

## 7. TOEKENNINGSVEREISTES TEN OPSIGTE VAN 'N BALK:

'n Balk kan toegeken word aan iemand aan wie die dekorasie reeds toegeken is en wat na sodanige toekenning en terwyl hy nog as lid van die Suid-Afrikaanse Polisie gedien het, hom weer onderskei het op die wyse soos in reël 6 beskryf. Ten opsigte van elke soortgelyke addisionele onderskeiding kan 'n addisionele balk toegeken word: Met dien verstande dat 'n goue, silwer- of laergraadsilwerbalk slegs aan 'n lid toegeken sal word wat in die besit van 'n ooreenstemmende dekorasie is. Andersins moet die toepaslike dekorasie toegeken word en nie die balk nie.

## 8. TOEKENNING, VERBEURDVERKLARING OF HERSTEL VAN DEKORASIE:

Die dekorasie, asook die balk ten opsigte daarvan, word deur die Staatspresident van die Republiek van Suid-Afrika toegeken en kan ook deur die Staatspresident ingetrek, nietig of verbeurd verklaar of herstel word.

## 9. POSTUUMTOEKENNING:

Die dekorasie, asook die balk ten opsigte daarvan, kan postuum toegeken word.

## 10. GRAVERING/STEMPEL VAN DEKORASIE:

Op die keersy van elke dekorasie wat toegeken word, word die magsnommer, rang en naam van die persoon wat die onderskeiding verwerf het, gestempel/graveer.

## 11. AFKONDIGING IN MAGSORDERS EN AANTEKENING IN REGISTER:

Die name van lede aan wie die dekorasie of balk toegeken word, word in die Suid-Afrikaanse Polisie-magsorders afgekondig en word tesame met sodanige besonderhede as wat die Kommissaris van die Suid-Afrikaanse Polisie dienstig ag, in 'n register by sy kantoor aangeteken.

12. Die bepaling van Reël 11 is *mutatis mutandis* van toepassing ten opsigte van die intrekking, nietigverklaring, verbeurdverklaring, en herstel van 'n dekorasie of balk.

13. Die dekorasie word op die linkerbors gedra en 'n balk wat ten opsigte daarvan toegeken is, word aan die lint geheg. Wanneer die dekorasie nie gedra word nie, word slegs die lint wat daarop betrekking het, op die linkerbors gedra, en indien 'n balk toegeken is, word die gespe wat saam met die balk uitgereik word, aan die lint geheg as aanduiding daarvan dat so 'n balk toegeken is.

14. Die toekenning van die dekorasie of balk verleen geen persoonlike voorrang aan die ontvanger nie, maar verleen aan hom die reg om die letters "PCFG", die afkorting van "PRAEFECTURAE CRUX FORTITUDINIS (GOUD)" of "PCFS" indien die betrokke dekorasie in silwer toegeken is of "PCF" indien die dekorasie in die laagste graad toegeken is, agter sy naam by te voeg: Met dien verstande dat slegs die letters van die hoër dekorasie gebruik mag word, ongeag of 'n laer of 'n hoër dekorasie eerste toegeken word.

15. 'n Miniatuurreproduksie, die helfte so groot as die dekorasie, kan by gepaste geleenthede gedra word.

16. 'n Verseëld model van elke dekorasie, asook die balk en lint ten opsigte daarvan, en van die miniatuurreproduksie daarvan moet veilig bewaar word in die kantoor van die Kommissaris van die Suid-Afrikaanse Polisie of op sodanige ander plek as wat die Staatspresident van die Republiek van Suid-Afrika mag bepaal.

## WARRANT

1. Delete the words "or gallantry" in the first sentence of the preamble.
