PUBLICATIONS OR OBJECTS.—EXEMPTION FROM SECTION 9 (4)

A Committee referred to in section 4 of the Publications Act, 1974 (the Act), has in terms of section 11 (2) of the Act decided that the undermentioned publication which is published by the *International Defence and Aid Fund for Southern Africa* is not undesirable within the meaning of section 47 (2) of the Act while the importation of all publications published by this publisher has been prohibited under section 9 (4) of the Act.
