AMENDMENT OF LEVY ON TIMBER AND IMPORTED TIMBER DERIVATIVES

By virtue of the powers vested in me by section 55 (1) of the Forest Act, 1984 (Act No. 122 of 1984), I, Gert Jeremias Kotzé, Minister of Environment Affairs and of Water Affairs, hereby amend the Annexure to Notice 577 of 31 March 1988 to the extent as set out in the Annexure hereto, with effect from 1 October 1989.

ANNEXURE

1. By the substitution for the words "fourteen comma eight (14,8) cents" in paragraph 2.2.1.1 of the words "fifteen comma eight (15,8) cents".

2. By the substitution for the words "sixty (60) days" in paragraphs 6.1 and 6.2 of the words "thirty (30) days".

3. By the substitution for paragraph 7.1 of the following paragraph:

"7.1 Interest

The classes of persons described in paragraph 5.1 may be required to pay interest on all levies not paid within the thirty (30) days allowed in terms of paragraphs 6.1 and 6.2 at the rate based on the prime interest rate on that date plus five per cent (5 %)."
