AMENDMENT OF GOVERNMENT NOTICE No. 1529 DATED 14 JULY 1989, AND THE TRANSFER OF ASSETS, LIABILITIES, RIGHTS, DUTIES, OBLIGATIONS AND POWERS FROM THE DEVELOPMENT BOARD (HOUSE OF REPRESENTATIVES) TO THE ENNERDALE LOCAL DEVELOPMENT COMMITTEE

By virtue of the powers vested in me by section 28A (4) (a) of the Development Act (House of Representatives), 1987 (Act No. 3 of 1987), I, David Michael George Curry, Minister of Housing, hereby amend Government Notice No. 1529 dated 14 July 1989, to the extent set out in the Schedule.

SCHEDULE

The words "to exercise the powers and to perform the functions and duties conferred upon or entrusted to the committee by the aforementioned Act in the Ennerdale Management Committee area as defined in Administrator's Notice 912 dated 4 August 1976" are hereby deleted and the following words are substituted therefor:

"to exercise in the Ennerdale area, as defined in the Schedule to Proclamation No. 42 of 10 February 1961 (as it appears in Administrator's Notice 912 of 4 August 1976), as well as in the areas defined in paragraphs (5) and (6) of the Schedule to Proclamation No. 112 of 25 June 1976, all powers of the former Peri-Urban Board in respect of Ennerdale that relate to the functions in connection with community development and local government and that were transferred in terms of Government Notice No. 1335 of 30 June 1989 to the Development Board established by section 3 of the Development Act (House of Representatives), 1987 (Act No. 3 of 1987), with the exception of the following powers:

- (i) Approval of the budget;
- (ii) raising of loans;

- (iii) aanstelling en ontslag van senior personeel van 'n rang gelykstaande met of hoër as adjunk-hoof wat in diens is van die Ontwikkelingsraad en die Ennerdale Plaaslike Ontwikkelingskomitee;
- (vi) uitvaardiging van regulasies of verordeninge;
- (v) die vasstelling van gelde, tariewe of ander vorderings; en
- (iv) die op lê van heffings of ander belastinge.

Verder verklaar ek dat ek al die bates, laste, regte, pligte en verpligtinge wat betrekking het op die bevoegdheide, regte en pligte van die voormalige Buitestedelike Raad ten opsigte van Ennerdale wat ingevolge Goewermenskennisgewing No. 1335 van 30 Junie 1989 aan voormelde Ontwikkelingsraad oorgedra is, aan die Ennerdale Plaaslike Ontwikkelingskomitee oordra en dat alle wetlik bepaalde formaliteite en vereistes ten opsigte van die uitoefening van enige reg, bevoegdheid, plig, verpligting of werksaamheid, deur die Ennerdale Plaaslike Ontwikkelingskomitee nagekom sal word."
