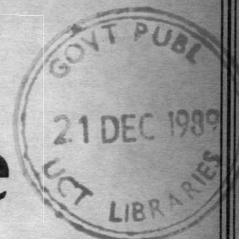

PROCLAMATION

AMENDMENT OF SCHEDULES 1 AND 2 TO THE
PUBLIC SERVICE ACT, 1984 (ACT No. 111 OF
1984)

Under the powers vested in me by section 6 (3) of the Public Service Act, 1984 (Act No. 111 of 1984), I hereby amend, in accordance with the recommendation of the Commission for Administration, Schedule 1 to the said Act with effect from 1 December 1989, by the deletion of the words "Department of Development Planning" and "Director-General: Development Planning" where they appear in columns I and II, respectively, and the insertion of the words "Department of Planning and Provincial Affairs" after the words "Department of National Health and Population Development" in column I, and the words "Director-General: Planning and Provincial Affairs" after the words "Director-General: National Health and Population Development" in column II.

Under the above-mentioned powers vested in me, I hereby also amend, in accordance with the recommendation of the Commission for Administration, Schedule 2 to the said Act with effect from 1 December 1989, by the insertion of the words "Constitutional Development Service" and "Constitutional Adviser" after the words "Bureau for Information" and "Head: Bureau for Information" in columns I and II, respectively.
