#### DIE NATALSE GENOOTSAP VIR GEOK- TROOIEERDE REKENMEESTERS

Kragtens die bepalings van artikel 12 van die Wet op die Transvaalse en Natalse Genootskappe van Geoktrooieerde Rekenmeesters, 1968 (Wet No. 66 van 1968), word die volgende wysigings deur die Minister van Finansies aan die verordeninge van die Natalse Genootskap van Geoktrooieerde Rekenmeesters, soos gepubliseer in Goewermentskennisgewing No. R. 347 van 6 Maart 1970, soos gewysig deur Goewermentskennisgewings Nos. R. 625 van 4 April 1975, 932 van 4 Junie 1976 en 1231 van 15 Junie 1979, afgekondig in die Bylae:

#### BYLAE

Verordening 60 (i) word gewysig deur die vervanging van verordening 60 (i) deur die volgende verordening:

60. (i) "Werwing of reklame of gunsverwing in die Republiek (of in enige gebied buite die Republiek wat van tyd tot tyd deur die Raad aangewys word) op enige wyse wat nie toegelaat word nie deur die Reëls of Kode van Professionele Gedrag wat van tyd tot tyd deur die Raad voorgeskryf word."

60. (i) "Soliciting or advertising or canvassing in the Republic (or in any territory outside the Republic designated by the Council from time to time) in any manner not permitted by the Rules or Code of Professional Conduct prescribed by the Council from time to time."
